The undersigned incorporator does hereby form a corporation under the Alabama Business Corporation Law, and does declare:

ARTICLE I
NAME

The name of the Corporation shall be Betty Bussey Designs, Inc.

TYPE OF ENTITY

The type of entity being formed is a business corporation.

ARTICLE III
PURPOSES

The purposes for which this Corporation is organized are:


