That in consideration of Two Hundred Eighteen Thousand Two Hundred Twenty Five dollars & no cents (\$218,225.00)

To the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt whereof is acknowledged, I, **Ivan K. Wheeler and Brittany Wheeler, husband and wife and Wanda C. Wheeler, and Terry M. Wheeler, wife and husband** (herein referred to as Grantor, whether one or more), do hereby grant, bargain, sell and convey unto **Larry Driskell** (herein referred to as grantee, whether one or more), the following described real estate, situated in Jefferson County, Alabama, to-wit:

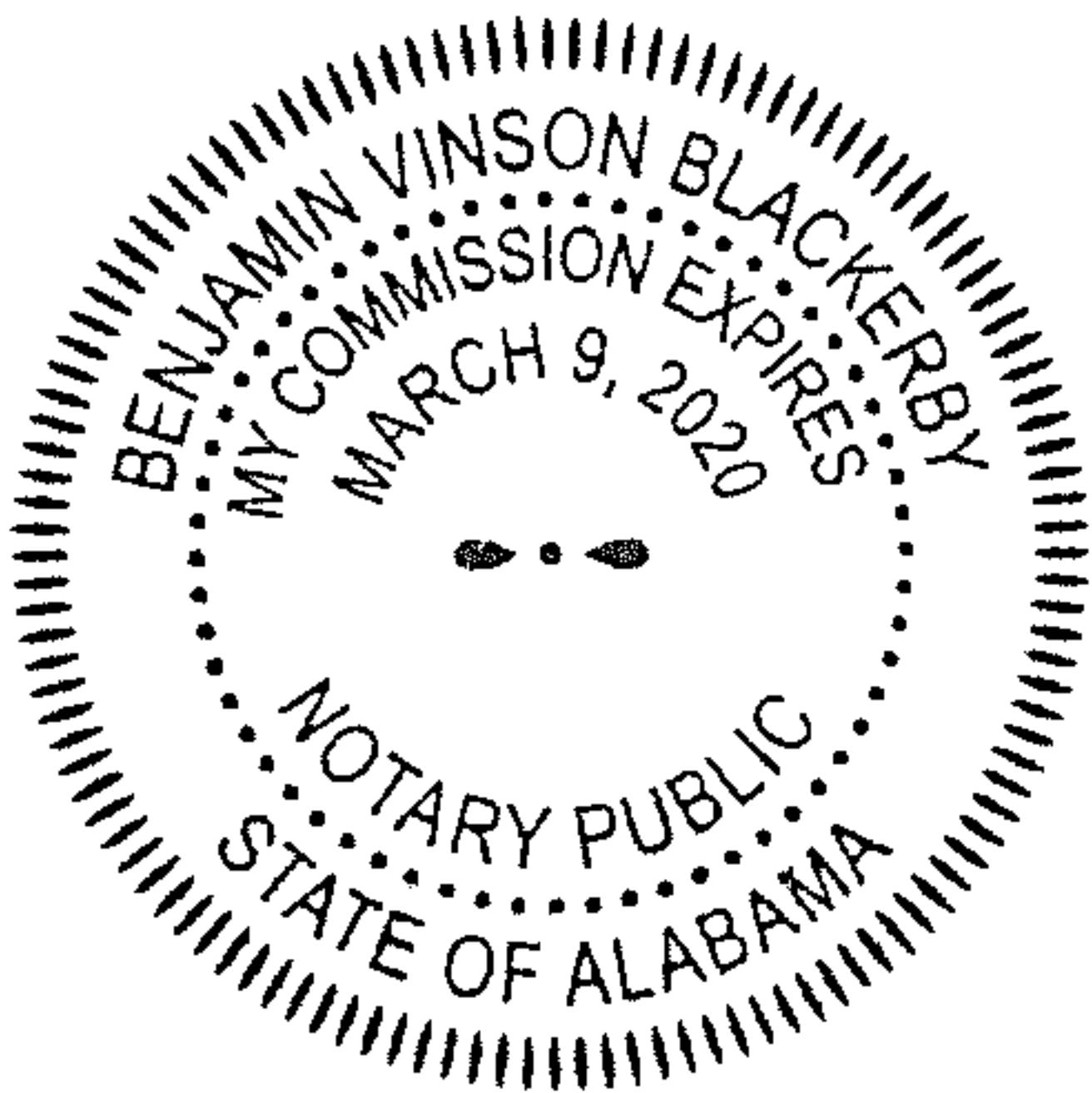

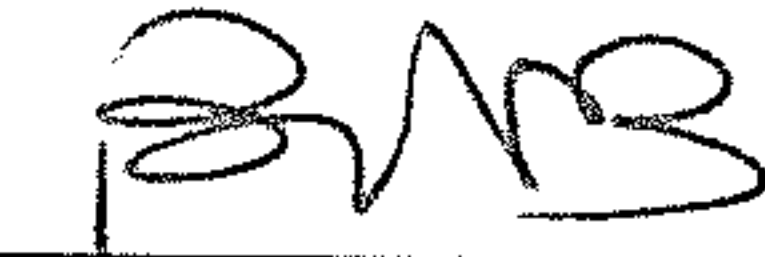

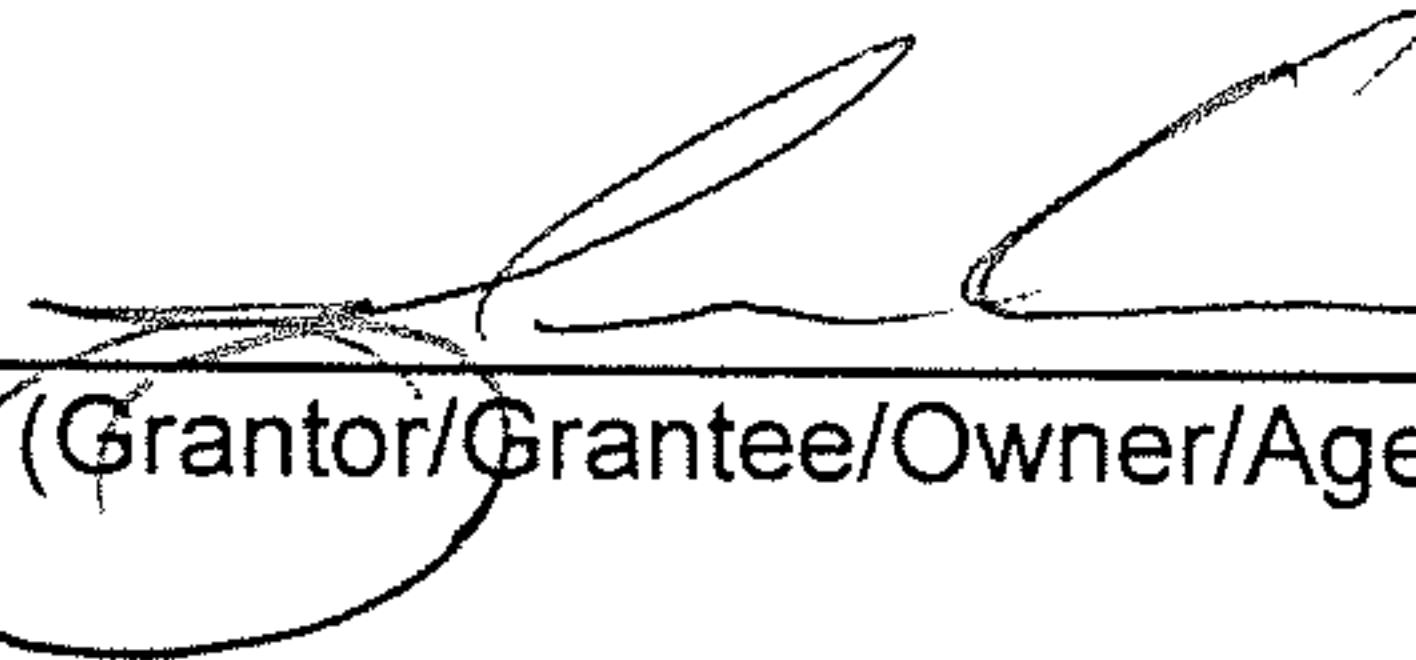
