GENERAL WARRANTY DEED
With Right of Survivorship

COUNTY OF Shelby } **KNOW ALL MEN BY THESE PRESENTS:**

THAT IN CONSIDERATION OF **One Hundred Ninety-One Thousand Dollars and NO/100 (\$191,000.00)** to the undersigned grantor, in hand paid by the Grantee herein, the receipt whereof is acknowledged, we, **James H. Walters, III and Vanessa Seaward Walters, husband and wife**, (herein referred to as **Grantors**), grant, sell, bargain and convey unto, **Monica Warren and Joshua Warren** (herein referred to as **Grantee** whether one or more), for and during their joint lives as joint tenants with rights of survivorship and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder or right of reversion, the following described real estate, situated in **Shelby County, Alabama** to wit:

Lot 9, according to the Survey of Shalimar Point, as recorded in Map Book 14, Page 105, in the Probate Office of Shelby County, Alabama.

Subject to easements, set back lines, restrictions, covenants, mineral and mining rights and current taxes due.


Vanessa Seaward Walters is formerly known as Vanessa A. Seaward. They are one and the same person.
