FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 2nd day of July, 2012, Stephen C. Gragg, a single person, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., as nominee for IberiaBank Mortgage Company, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20120705000236470, said mortgage having subsequently been transferred and assigned to PennyMac Loan Services, LLC, by instrument recorded in Instrument number 20171207000439330, in the aforesaid Probate Office ("Transferee"); and
