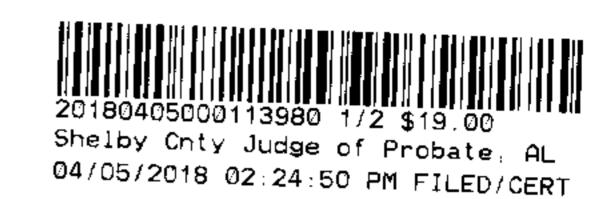
WARRANTY DEED

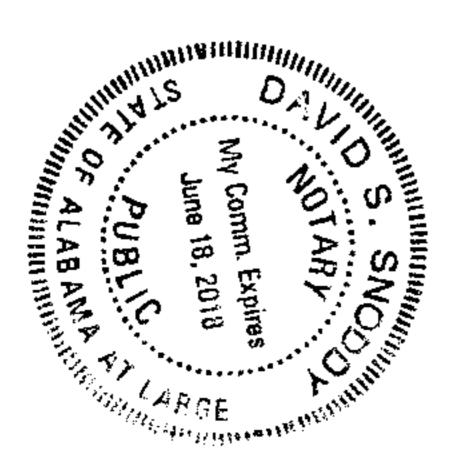

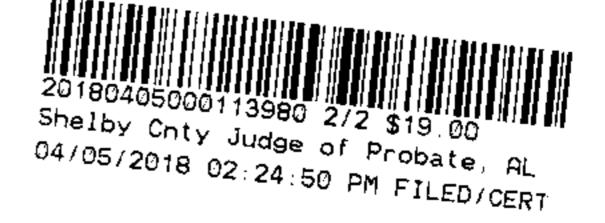
