**GENERAL WARRANTY DEED

THAT IN CONSIDERATION OF **Three Hundred Eighty-Nine Thousand Nine Hundred Dollars and NO/100 (\$389,900.00)** to the undersigned grantor, in hand paid by the Grantee herein, the receipt whereof is acknowledged, we, **Robert L. McDaniel and Monica T. 
