THIS IS A PERSONAL REPRESENTATIVE'S DEED executed and delivered this day of April, 2018 by SHERRY M. CROWDER, in her capacity as Personal Representative of the Estate of CHARLES R. CROWDER, Deceased (hereinafter referred to as the "Grantor"), to SHERRY M. CROWDER, an unmarried woman (hereinafter referred to as the "Grantee").

WHEREAS, ON January 25, 1993, the real property described herein was conveyed by **JOHN WILSON JAMISON**, III and his wife, **MARGARET MORRISON JAMISON** to **CHARLES R. CROWDER** and **SHERRY M. CROWDER** by Warranty Deed which was recorded on January 27, 1993 in the Office of the Judge of Probate of Shelby County, Alabama.

WHEREAS, CHARLES R. CROWDER died on January 15, 2010 and his Estate is being administered in the Probate Court of Shelby County, Alabama, being Case Number PR-2010-000207. SHERRY M.
