
Subject to: All easements, restrictions and rights of way of record.

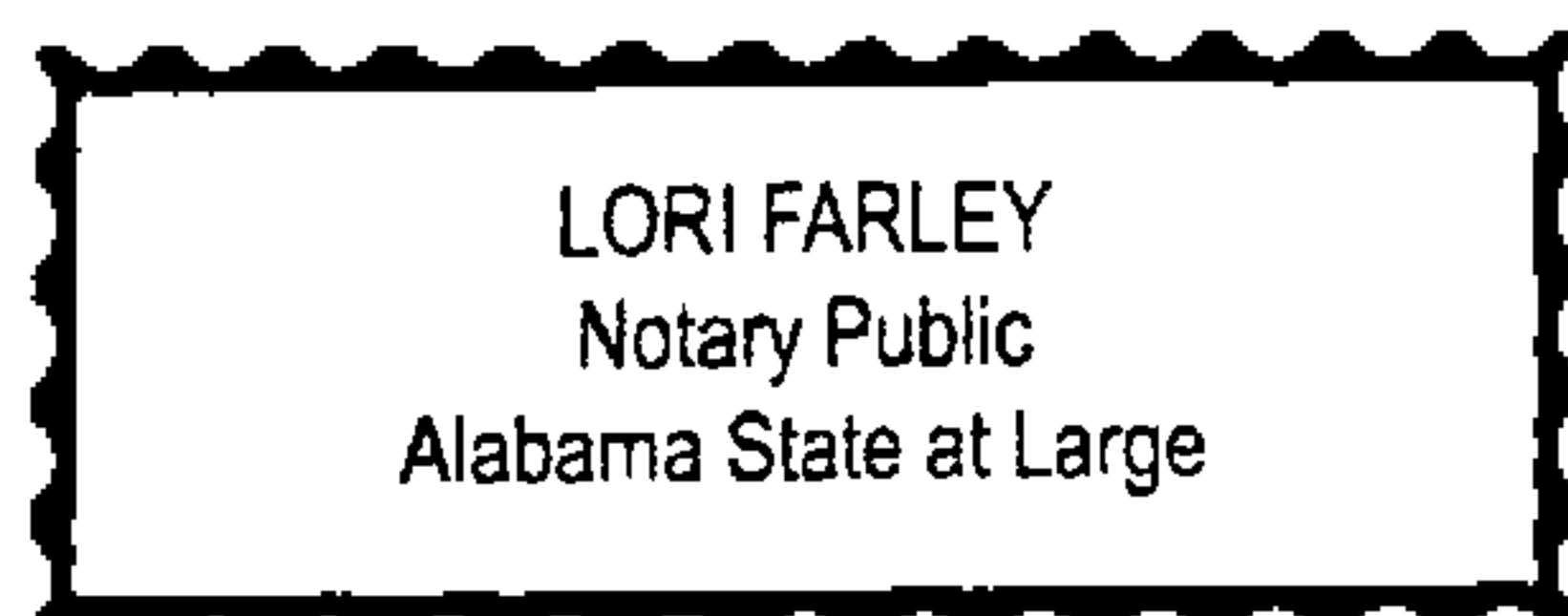
