GENERAL WARRANTY DEED
With Right of Survivorship

KNOW ALL MEN BY THESE PRESENTS:

THAT IN CONSIDERATION OF **One Hundred Seventy Thousand Dollars and NO/100 (\$170,000.00)** to the undersigned grantor, in hand paid by the Grantees herein, the receipt whereof is acknowledged, I, **Pamela Swiatek, a married** person, (herein referred to as **Grantor**), grant, sell, bargain and convey unto, **Joseph Mark LeJeune and Amy Branch LeJeune** (herein referred to as **Grantee** whether one or more), for and during their joint lives as joint tenants with rights of survivorship and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder or right of reversion, the following described real estate, situated in **SHELBY** County, Alabama to wit:

The NW 1/4 of the NW 1/4 of Section 29, Township 21, Range 1 East in Shelby County, Alabama, being more particularly described as follows:
