ARTICLES OF ORGANIZATION

OF

For the purpose of forming a limited liability company under the Alabama Limited Liability Company Act, ALABAMA CODE Section 10-12-1 et seq.  - (c) To have and to exercise any and all of the powers specifically granted in the Act, none of which shall be deemed to be inconsistent with the nature,

character or the object of the Company and none of which are denied to it by these Articles of Organization.

ARTICLE IV


