Williams Perry is deceased, having died on 10 Sept 1987.

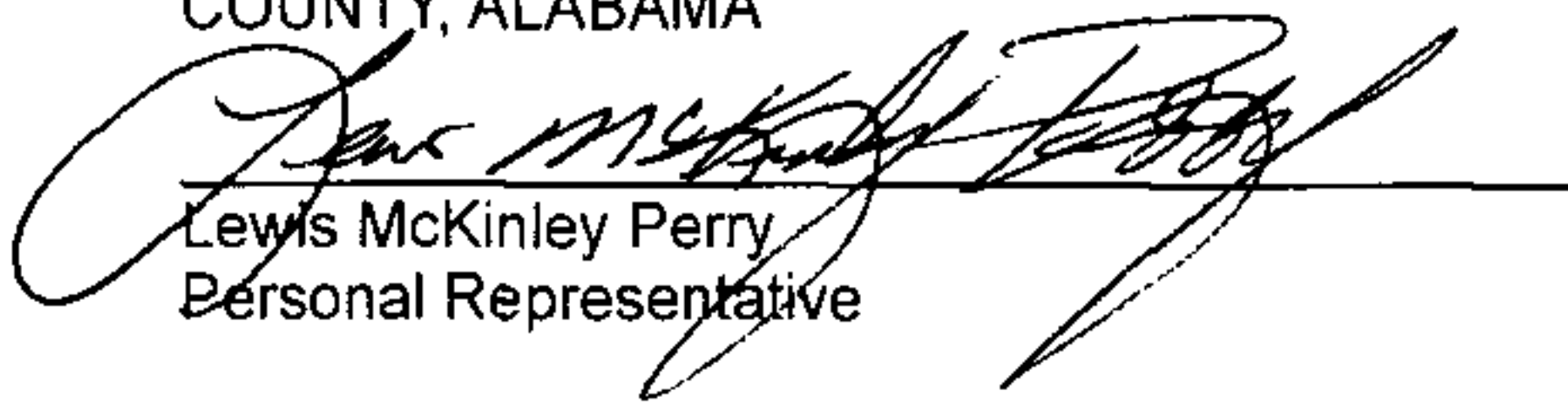
\$0.00 of the purchase price of the above described property was financed with the proceeds of a mortgage loan closed simultaneously herewith.

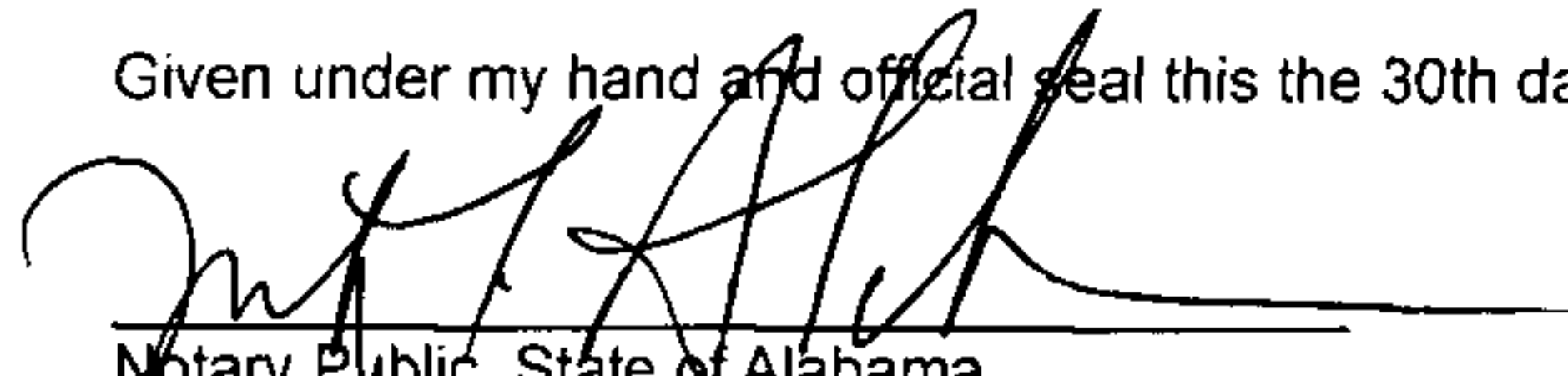

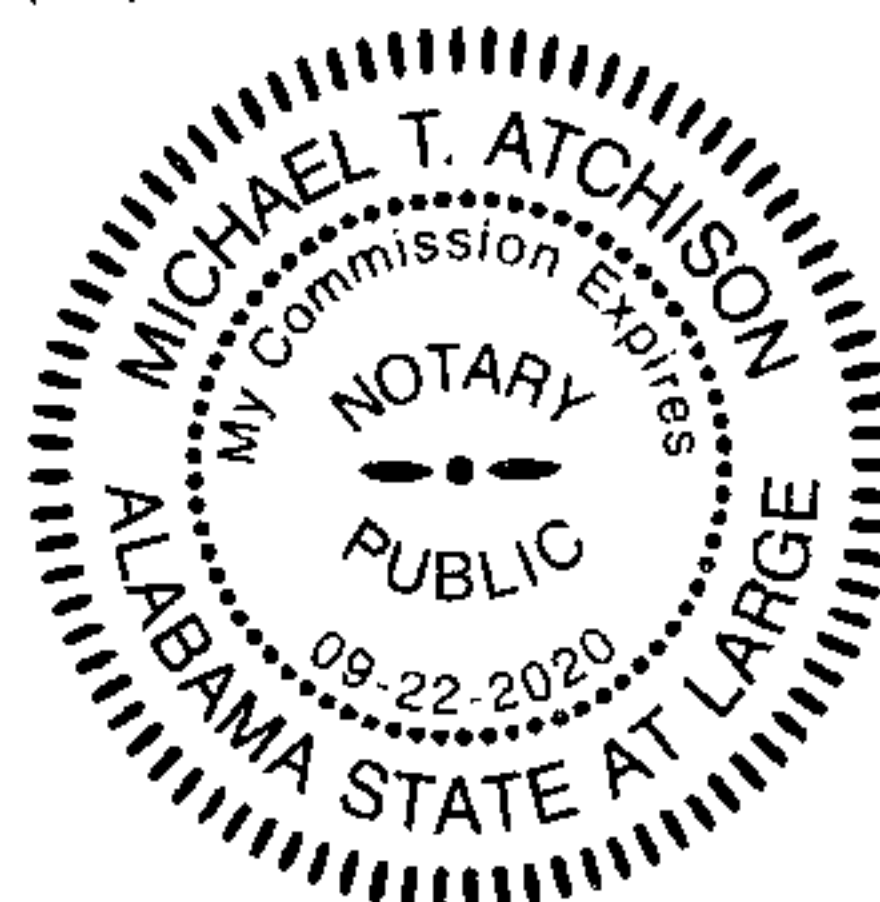
