WHEREAS, heretofore, on to-wit, September 28, 2012, Ronald Dewayne Beasley, A Married Man, Mortgagor, did execute a certain mortgage to Mortgage Electronic Registration Systems, Inc., as nominee for Hometown Mortgage, Services, Inc., its successors and assigns

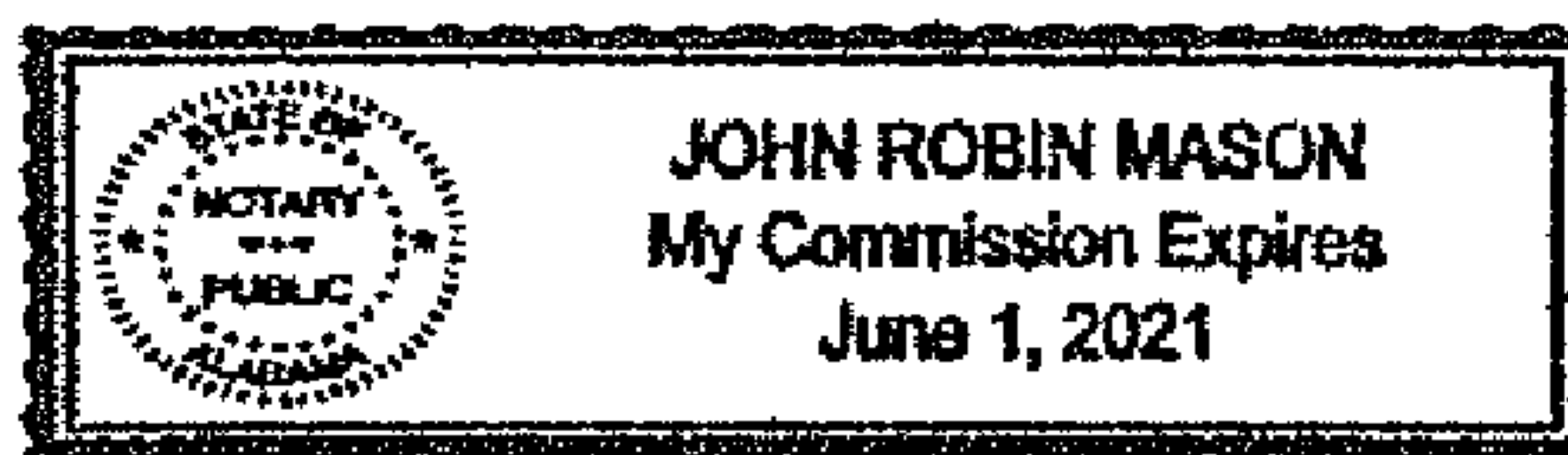

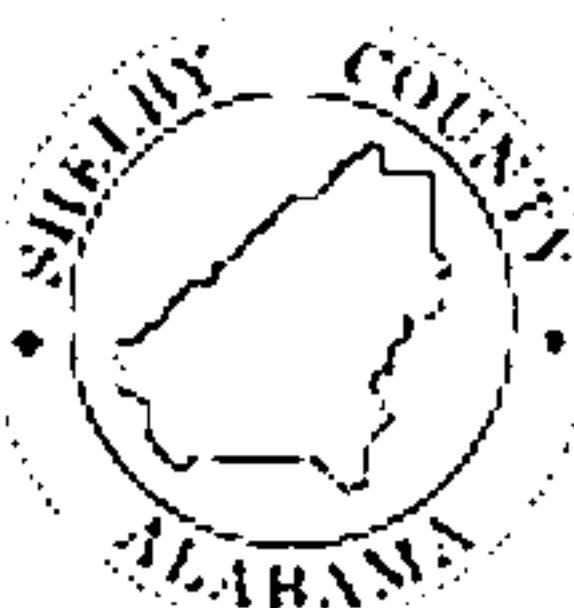
