**WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP**

KNOW ALL MEN BY THESE PRESENTS

That in consideration of **Five Hundred Eight Thousand and 00/100 Dollars (\$508,000)** to the undersigned grantor in hand paid by the grantees herein, the receipt whereof is acknowledged, I,

**James E. Skoney, a married man**

(hereinafter referred to as "Grantor") do grant, bargain, sell and convey unto

**Edward R. Stubblefield and Brooke M. Stubblefield**

(hereinafter referred to as "Grantees") as joint tenants with right of survivorship, the following described real estate situated in **Shelby County, Alabama** to-wit:

**Lot 3, Block 4, according to the Plat of Woodford, a subdivision of Inverness, as recorded in Map Book 8, Page 54 A, B, C and D, in the Probate Office of Shelby County, Alabama, being situated in Shelby County, Alabama.**


**\$453,100** of the proceeds come from a mortgage recorded simultaneously herewith.

And I do for myself and for my heirs, executors, and administrators covenant with Grantees, their heirs and assigns, that I am lawfully seized in fee simple of said premises; that they are free from all encumbrances, unless otherwise noted above; that I have a good right to sell and convey the same as aforesaid; that I will and my heirs, executors and administrators shall warrant and defend the same to Grantees, their heirs and assigns forever, against the lawful claims of all persons.


