



KNOW ALL MEN BY THESE PRESENTS, that for and in consideration of the sum of Four Thousand Two Hundred and no/100 (\$4,200.00) ----- dollar(s), cash in hand paid to the undersigned by the State of Alabama Department of Transportation, the receipt of which is hereby acknowledged, I (we), the undersigned grantor(s), Nina Jane Halbert, a *MARRIED* woman, have this day bargained and sold, and by these presents do hereby grant, bargain, sell and convey unto the State of Alabama the following described property:

A part of the SW ¼ of SE ¼, Section 20, Township 24 North, Range 15 East, identified as Tract No. 6 on Project No. BR-0145 (504) in Shelby County, Alabama and being more fully described as follows:

Parcel 1 of 1:

Commencing at a right of way monument located on the East present R/W line of SR-145 (said point is located 3166.10 feet North of the intersection of the said East present R/W line and the centerline of Waxahatchee Creek);

Thence S 27°33'00" W along said East present R/W line a distance of 2110.59 feet to a point on the acquired R/W line (said point ties to said East present R/W line right of project centerline and perpendicular at station 130+83.00);

Thence S 62°27'00" E along said acquired R/W line a distance of 21.56 feet, more or less, to a point on the acquired R/W line (said point is offset 122.00 feet right of and perpendicular to project centerline at station 130+81.31);

Thence S 07°46'06" W along said acquired R/W line a distance of 65.50 feet to a point on the acquired R/W line and the **Point of Beginning**;

Thence S 07°46'06" W along the acquired R/W line a distance of 52.77 feet to a point on the grantor's property line;

Thence N 89°14'22" W along the grantor's property line a distance of 69.00 feet to a point on said East present R/W line;


Thence N 27°33'00" E along said East present R/W line a distance of 56.39 feet to a point on the grantor's property line;

Grantor also certifies that the above described property constitutes no part of her present homestead.




TO HAVE AND TO HOLD, unto the State of Alabama, its successors and assigns in fee simple forever.


