That in consideration of **Four Hundred Fifty Thousand and 00/100 Dollars (\$450,000.00)** to the undersigned grantor in hand paid by the grantees herein, the receipt whereof is acknowledged, we,

**Laura W. Bennett and her husband David Bennett**

(hereinafter referred to as "Grantor") do grant, bargain, sell and convey unto

**Jeremy E. Estes and Courtney W. Estes**

(hereinafter referred to as "Grantees") as joint tenants with right of survivorship, the following described real estate situated in **Shelby** County, Alabama to-wit:

**Lot 239, according to the Survey of Brook Highland, an Eddleman Community, 6th Sector, 2nd Phase, as recorded in Map Book 15, page 50 A & B, in the Probate Office of Shelby County, Alabama**

\$360,000.00 of the proceeds come from a mortgage recorded simultaneously herewith.



And I do for myself and for my heirs, executors, and administrators covenant with Grantees, their heirs and assigns, that I am lawfully seized in fee simple of said premises; that they are free from all encumbrances, unless otherwise noted above; that I have a good right to sell and convey the same as aforesaid; that I will and my heirs, executors and administrators shall warrant and defend the same to Grantees, their heirs and assigns forever, against the lawful claims of all persons.

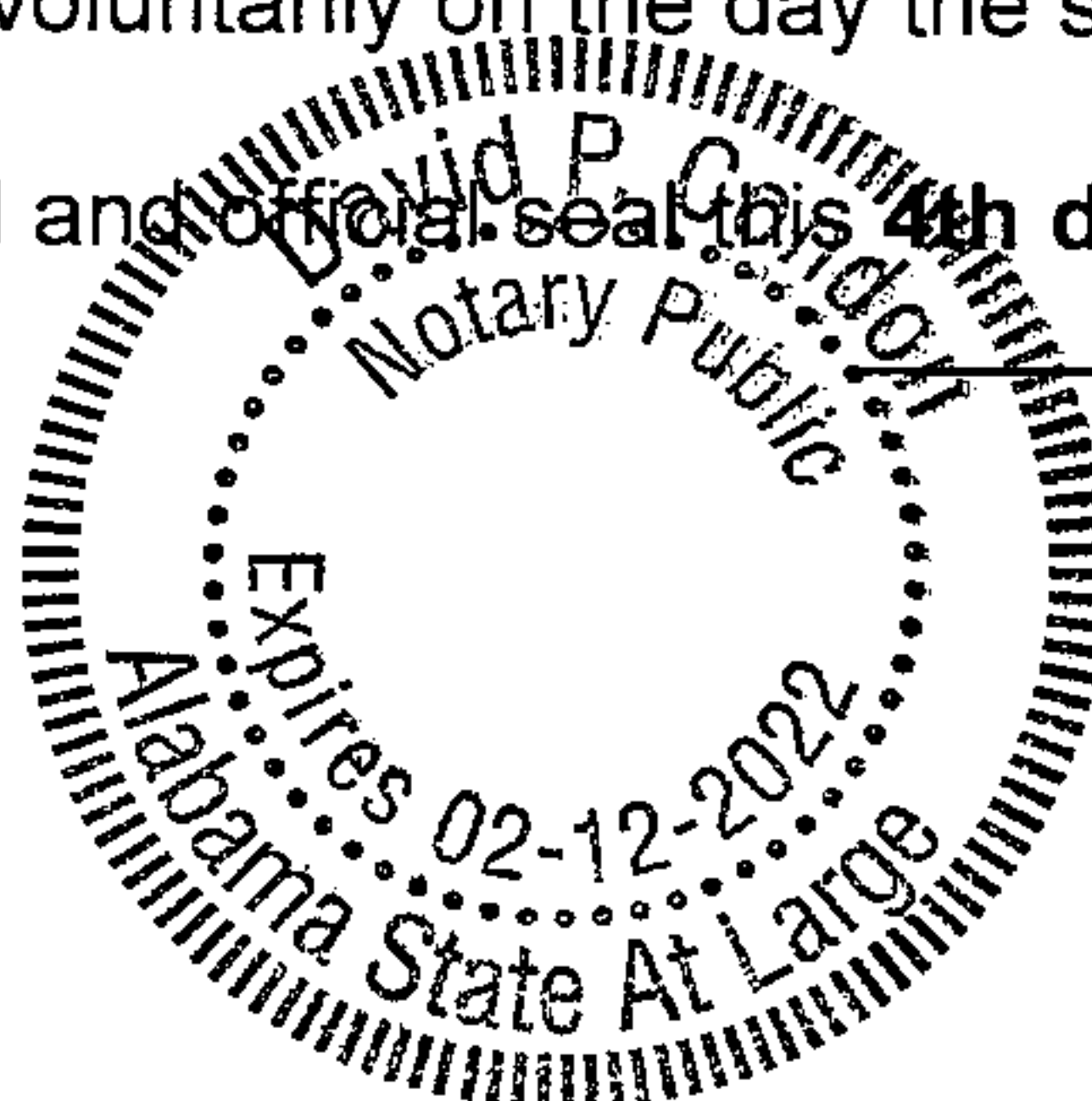
