

## ORDINANCE NO. 116-05

AN ORDINANCE REPEALING SECTION 3-10 OF THE CODE OF ORDINANCES FOR THE CITY OF PELHAM AND CREATING AN ORDINANCE IN CHAPTER 11.5 PARKS AND RECREATION, ARTICLE 1., SEC. 11.5-4.

WHEREAS, it is the goal of the City of Pelham Park and Recreation Department to enhance the community's quality of life by providing well designed and properly maintained parks, walking trails and recreational opportunities for all in Pelham; and

WHEREAS, Pursuant to the recommendation of the City Council for the City of Pelham the following ordinance will advance the goals of the Park and Recreation Department and preserve park facilities for long term use; promote recreational opportunities for the community; and protect the health, safety, and welfare of the residents of the City of Pelham.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Pelham, Alabama as follows:

- **Section 1.** Section 3-10 of the Code of Ordinances of the City of Pelham is hereby repealed, and the following provisions of this Ordinance shall be contained and form Chapter 11.5 Parks and Recreation, Article1, Section 11.5-4 of said code:
- 1) The City Council shall adopt promulgated rules to achieve the listed goals. Promulgated rules shall be presented to the Council through the Park and Recreation Director. The Park and Recreation Director shall review all rules annually to assure they are appropriate for the Pelham Parks and Recreation facilities. Once the rules have been approved, these recommendations will be adopted as the official facility rules for the Pelham Park and Recreation facilities. The council has the authority to modify or repeal a rule that is deemed to be in the best interest of the citizens of Pelham at any time by a majority vote.
- 2) The current facilities falling under this ordinance will be Pelham Recreation Center, Pelham Racquet Club, Pelham Tennis Center, Pelham Youth Baseball/Softball facility, Carroll Park, Creekview Park, Coker Park, and when completed and opened officially for use by recommendation of the Director, the Pelham Pups Dog Park and Pelham Greenway and trail system.
- 3) Fun Go Holler Park and the Outdoor Basketball/Sand Volleyball courts next to the Recreation Center are a Shelby County and Pelham joint venture project and will require involvement from Shelby County for rules adoption.
- 4) The Park and Recreation Director, specific athletic manager, and sport specific board will be responsible for establishing the rules for each youth and adult sport.
- Section 2. That the City Clerk/Treasurer shall file a certified copy of this ordinance containing an accurate description of said annexed territory with the Probate Judge of Shelby County, Alabama, and also cause a copy of this ordinance to be published in accordance with state law.

Section 3.	That this Ordinance shall become effective upon its passage and publication or


