
1. Advalorem taxes for the current tax year.
2. Easements, restrictions, reservations and conditions of record.



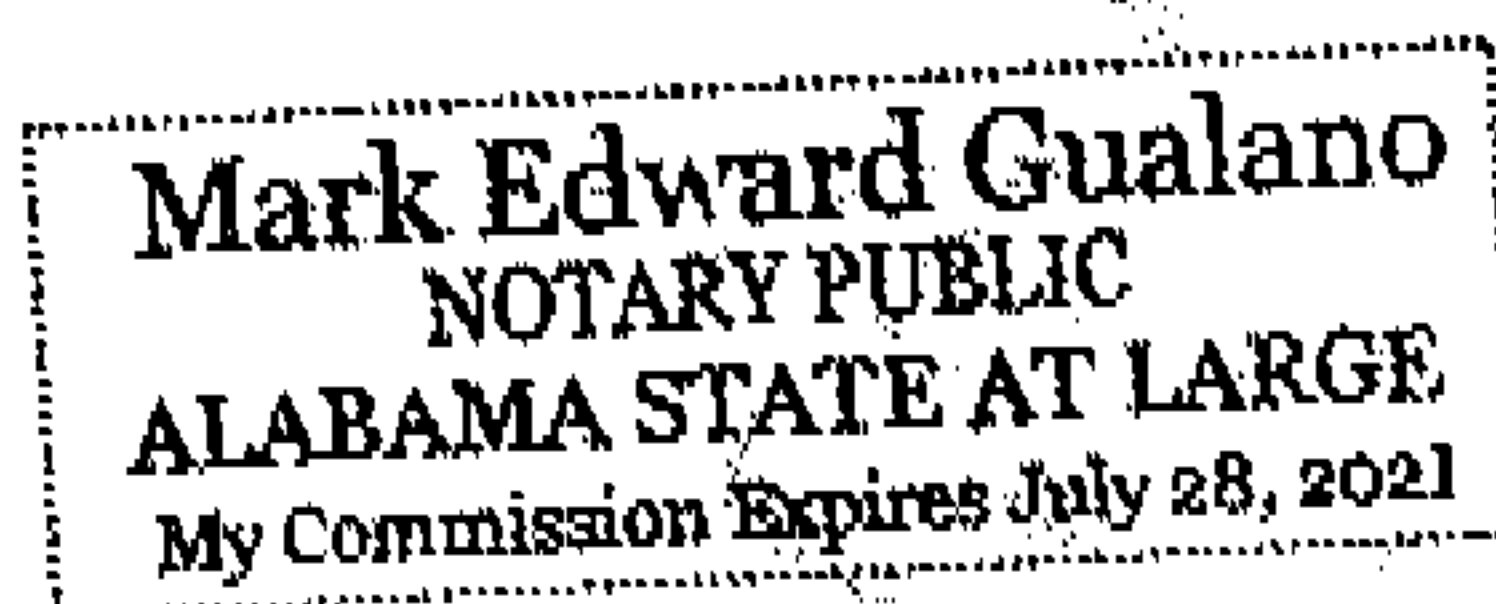
