MORTGAGE FORECLOSURE DEED

WHEREAS, heretofore, on to-wit, July 30, 2009, Christopher P Willard, Jr, Husband Engris G Willard, Wife , Mortgagor, did execute a certain mortgage to Mortgage Electronic Registration Systems, Inc., as nominee for SunTrust Mortgage, Inc., its successors and assigns, which said mortgage is recorded in Instrument No. 20090811000308730, in the Office of the Judge of Probate of Shelby County, Alabama; and

WHEREAS, on April 23, 2018, the day on which the foreclosure sale was due to be held under the terms of said notice at 11:10 o'clock ampm, between the legal hours of sale, said foreclosure was duly and properly conducted and SunTrust Mortgage, Inc. did offer for sale and sell at public outcry, in front of the main entrance of the courthouse door of the Shelby County, Alabama Courthouse, in the City of Calera, Alabama, the property hereinafter described; and

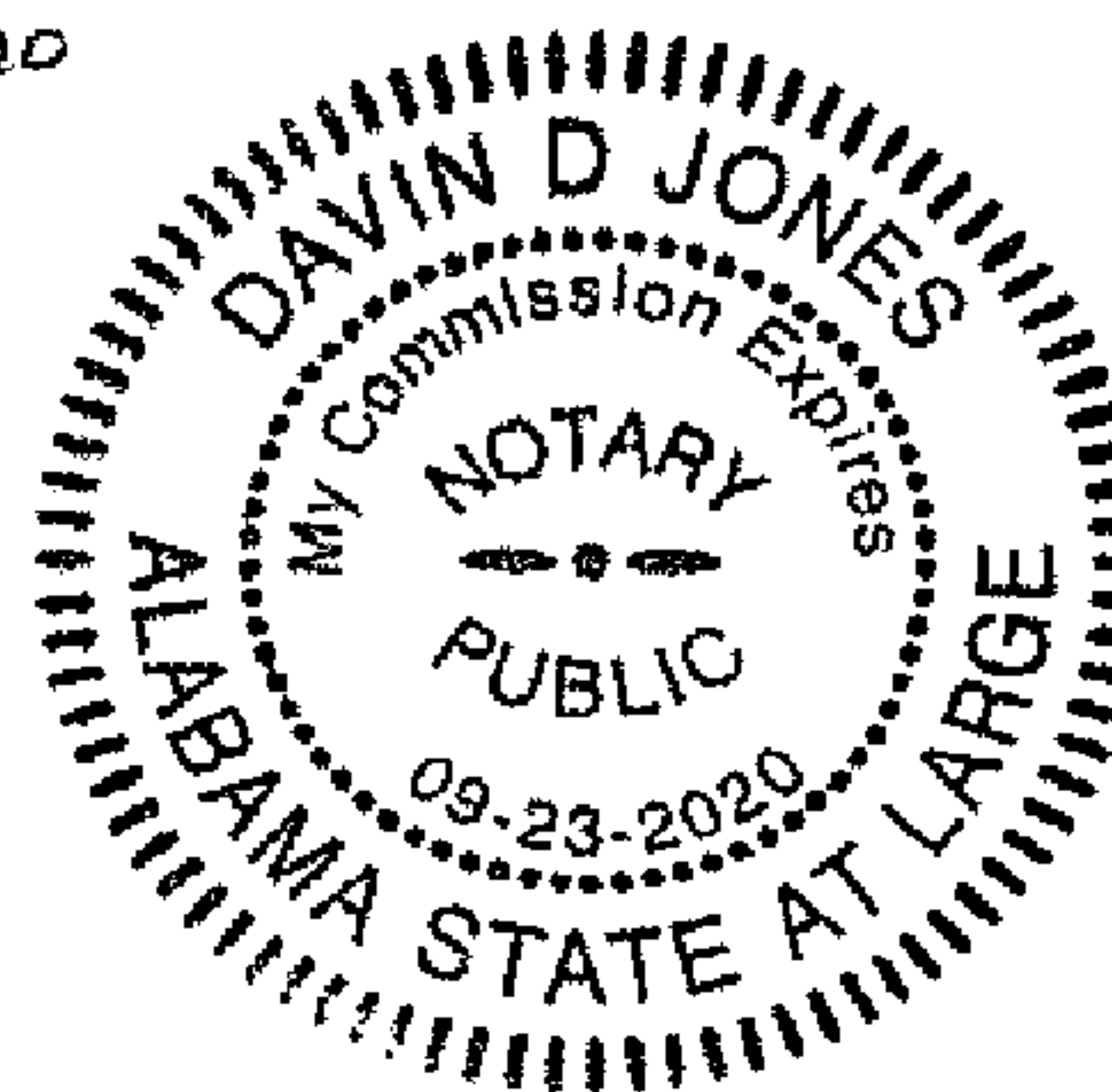

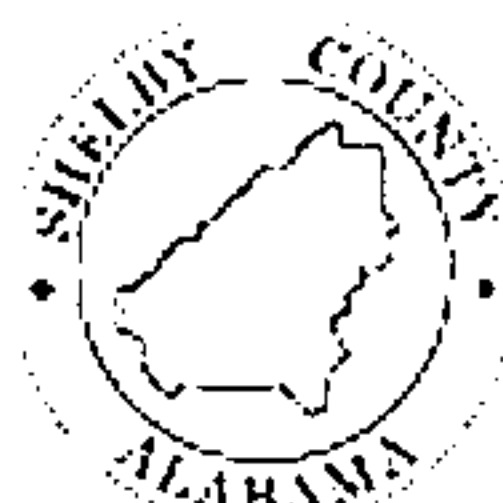
