**GENERAL WARRANTY DEED

THAT IN CONSIDERATION OF **One Hundred Forty-Four Thousand Dollars and NO/100 (\$144,000.00)** to the undersigned grantor, in hand paid by the Grantees herein, the receipt whereof is acknowledged, I, **Fabray Turner, a married person conveying property that is not her homestead nor that of her spouse**, (herein referred to as **Grantor**), grant, sell, bargain and convey unto, **Francisco Javier Espinoza Pena and Andrea P. Arana Flamenco** (herein referred to as **Grantee** whether one or more), for and during their joint lives as joint tenants with rights of survivorship and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder or right of reversion, the following described real estate, situated in **SHELBY** County, Alabama to wit:
