MORTGAGE FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, That:

WHEREAS, heretofore, on to-wit, May 19, 2008, **Lashel C. Hale A/K/A Lashel Toyer, A Single Woman, Mortgagee**, did execute a certain mortgage to **Mortgage Electronic Registration Systems, Inc. solely as nominee for Federal Guaranty Mortgage Co. its successors and assigns**, which said mortgage is recorded in Instrument No. 20080530000219660 as modified by that certain Modification Agreement in Instrument No. 20160307000071640, in the Office of the Judge of Probate of Shelby County, Alabama; and

WHEREAS, said mortgage and the debt thereby secured was last transferred and assigned to **Branch Banking and Trust Company**, as transferee, said transfer is recorded in Instrument 20150505000147340, aforesaid records, and Branch Banking and Trust Company, is now the holder and owner of said mortgage and debt; and

WHEREAS, on April 25, 2018, the day on which the foreclosure sale was due to be held under the terms of said notice at 1:15 o'clock pm, between the legal hours of sale, said foreclosure was duly and properly conducted and Branch Banking and Trust Company did offer for sale and sell at public outcry, in front of the main entrance of the courthouse door of the Shelby County, Alabama Courthouse, in the City of Calera, Alabama, the property hereinafter described; and

WHEREAS, the highest and best bid for cash obtained for the property described in the aforementioned mortgage was the bid of Spartan Invest, LLC in the amount of **ONE HUNDRED TWENTY-SEVEN THOUSAND TWO HUNDRED ONE DOLLARS AND NO CENTS (\$127,201.00)** which sum the said Branch Banking and Trust Company offered to credit on the indebtedness secured by said mortgage, and said property was thereupon sold to the said Spartan Invest, LLC; and

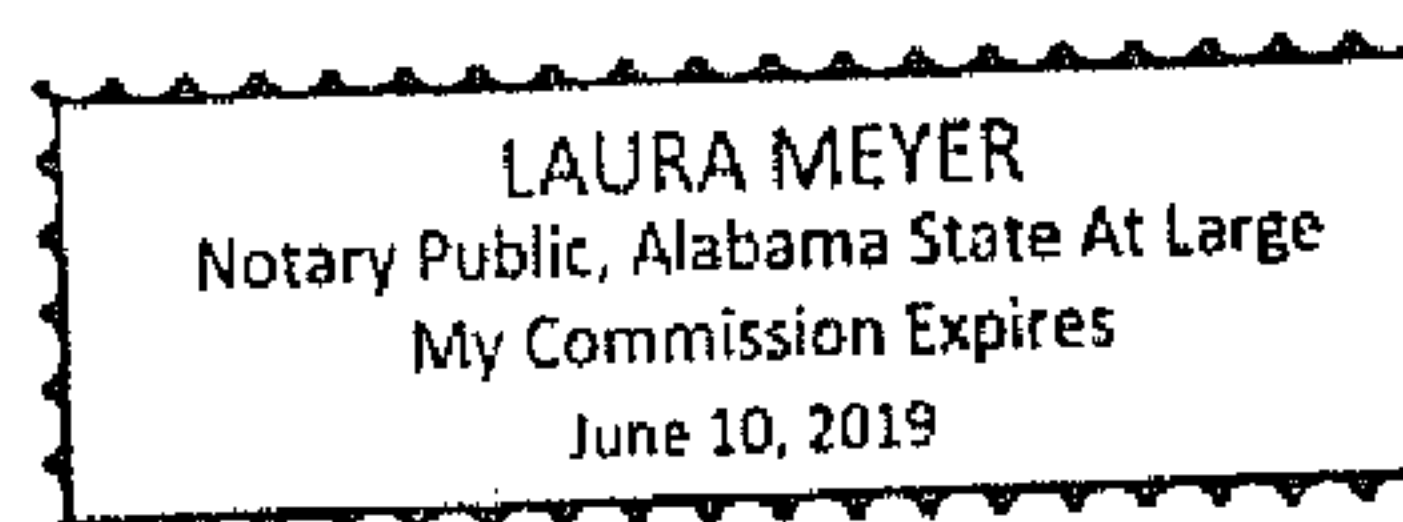
