

CERTIFICATE OF MERGER

In accordance with the provisions of the Alabama Business and Nonprofit Entities Code, the following Certificate of Merger is hereby delivered for the purpose of merging (the "Merger") Trussville Orthodontics, LLC, an Alabama limited liability company ("Trussville Orthodontics"), with and into Wolfe Orthodontics, LLC ("Wolfe Orthodontics"), an Alabama limited liability company, with Wolfe Orthodontics being the surviving limited liability company in the Merger:


1. Trussville Orthodontics, LLC is an Alabama limited liability company with Alabama entity ID number 268-382, which was formed in Jefferson County, Alabama on October 11, 2012.
2. Wolfe Orthodontics, LLC is an Alabama limited liability company with Alabama entity ID number 444-757, which was formed in Shelby County, Alabama on March 18, 2010.
3. The effective date of the merger shall be May 1, 2018.
4. The surviving limited liability company of the Merger shall be Wolfe Orthodontics.
5. The undersigned certify that the Plan of Merger has been approved and executed by each of the entities, which are to merge in accordance with the Alabama Business and Nonprofit Entities Code.
6. The undersigned certify that if the surviving or resulting entity is one in which one or more owners lack limited liability protection, each owner of an entity party to the merger who is to be an owner of the surviving entity without limited liability protection has consented to the merger in writing.
7. The undersigned certify that a copy of the Plan of Merger shall be furnished on request and without cost to any owner of any entity, which is a party to this merger.
8. The executed Certificate of Merger and Plan of Merger are on file at the office of the surviving limited liability company located at 500 Riverwoods Parkway, Helena, AL 35080.

without cost, to any member of Wolfe Orthodontics or Trussville Orthodontics.


