
# **ARTICLES OF ORGANIZATION**

# Dynamic Marketing Designs, LLC

The undersigned, Gail Ann Dasher, acting as the organizer of Dynamic Marketing Designs, LLC, under the provisions of the Alabama Limited Liability Company Law, Code of Alabama 1975 §10A-5-1.01 et seq. (hereinafter sometimes the Law) adopt the following Articles of Organization for Dynamic Marketing Designs, LLC:

## **ARTICLE I**

### NAME

1.0 Identity of L.L.C. The name of the limited liability company herewith organized by her is Dynamic Marketing Designs, LLC (hereinafter sometimes the Company).

## **ARTICLE II**

#### **DURATION**

- 2.0 Duration of Company's Existence. The Company shall commence on the date of the filing of these Articles of Organization in the Office of the Judge of Probate of Shelby County, Alabama, which is the county in which the initial registered office of the Company is located, and its existence shall be perpetual unless the Company is dissolved pursuant to the unanimous written consent of all of its Members, or as provided in the Operating Agreement, or as may be required by the Law or the laws of the State of Alabama.
- 2.1 No Liability. The Members of the Company shall have no liability for any debt, obligation, or liability of the Company, as provided in the Law.

#### **ARTICLE III**

## **PURPOSES**

3.0 To Engage in Any Lawful Activity. The purpose of the Company shall be to engage in any lawful business or activity permitted by the Law.

- 3.1 To Exercise all Powers. To exercise all other powers necessary to or reasonably connected with the Company's business that may be legally exercised by limited liability companies under the Alabama Law.
- 3.2. To Engage in All Necessary Activities. To engage in all activities necessary, customary, convenient, or incident to any of the foregoing.

## **ARTICLE IV**

## REGISTERED OFFICE AND REGISTERED AGENT

4.0 Initial Registered Office and Agent. The address of the initial registered office of the Company is 1617 Napoleon Drive, Alabaster, AL 35007. The name of its initial registered agent at such address is Gail Ann Dasher.


5.0 Identity of Initial Members. The names and mailing addresses of the initial members of the Company are as follows:

- 5.1 Transferability of a Member's Interest. The transferability of the interest of a Member in the Company may be restricted by the provisions of an Operating Agreement adopted by the Members.

- 6.0 Admission to Membership. From the date of the filing of these Articles in the Office of the Judge of Probate of Shelby County, Alabama, any person or entity acceptable to the Members by their unanimous vote may become a member in this Company either by the issuance by the Company of membership interests for such consideration as the Members by their unanimous votes shall determine, or as a transferee of a Member's membership interest or any portion thereof, subject to the terms and conditions of any Operating Agreement adopted by the Members.
- 6.1 Financial Adjustments. No new members shall be entitled to any retroactive allocation of losses, income or expense deductions incurred by the Company. The Management Committee of the Company may, at its option, at the time a member is admitted, close the Company's books (as though the Company's tax year had ended) or make *pro rata* allocations of loss, income, and expense deductions to a new member for that portion of the Company's tax year in which a member was admitted in accordance with the provisions of Section 706(d) of the Internal Revenue Code of 1986 and the U. S. Department of Treasury Regulations promulgated thereunder.

#### **ARTICLE VII**

## RIGHTS TO CONTINUE BUSINESS OF COMPANY

7.0 Continuation After Dissociation. The dissociation of a Member of the Company or the occurrence of any other event which terminates the continued membership of a Member of the Company shall not comprise a discontinuance of the business of the Company nor shall it cause the Company to be dissolved.

## **ARTICLE VIII**

## MANAGEMENT OF COMPANY

- 8.0 Company to be Managed By A Manger. The business and affairs of the Company shall be managed by one or more Managers. The Manager shall direct, manage, and control the business of the Company to the best of its ability. The name and mailing address of the initial Manager, who shall as Manager until the first annual meeting of members of the Company or until a successor is duly elected shall be Gail Ann Dasher, 1617 Napoleon Drive, Alabaster, AL 35007.
- 8.1. Appointment of Officers. The Manager may appoint individuals with such other titles as it may select, including the titles of Chairman, President, Vice President, Treasurer and

Secretary, to act on behalf of the Company, with such power and authority as the Manager may delegate to any such individual.
