 - (3) any minerals or mineral rights leased, granted, or retained by prior owners.



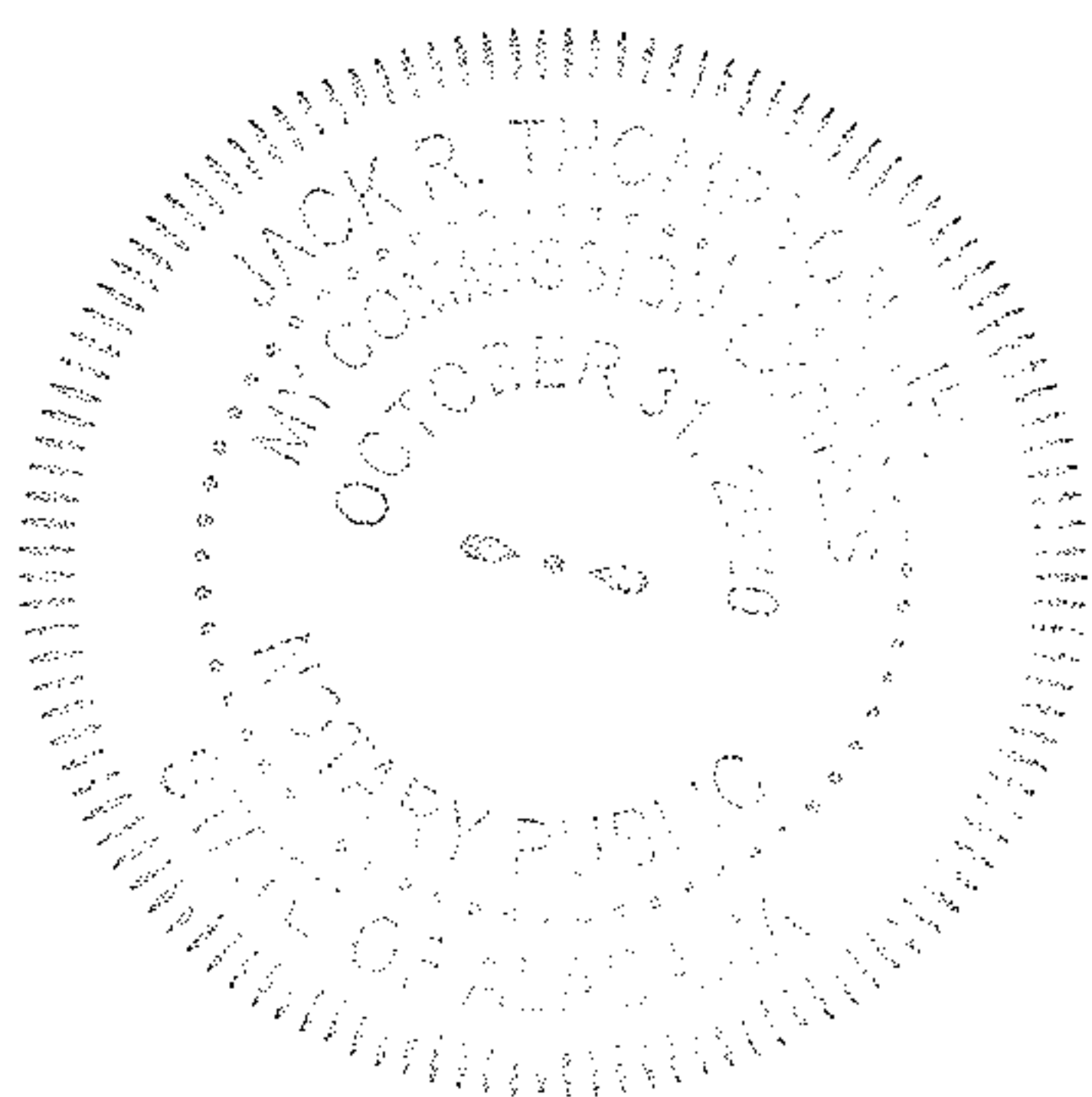
