Lot 1, according to the survey of Benson Family Subdivision, as recorded in Map Book 39, Page 136, in the Probate Office of Shelby County, Alabama.





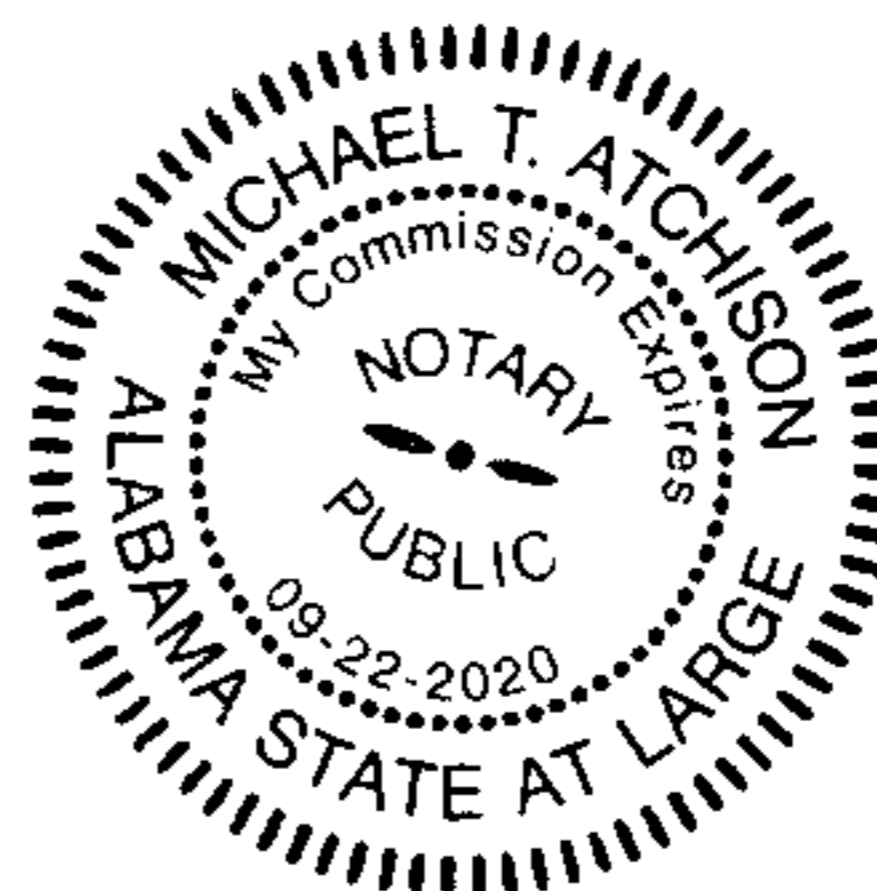
