WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS, that in consideration of One Hundred ~~Ninety~~ Thousand Dollars and No Cents (\$190000.00) and other good and valuable consideration the receipt and sufficiency whereof is hereby acknowledged, Terry Wayne Hosey and Sherry Gail Hosey, husband and wife (herein referred to as GRANTOR) does by these presents grant, bargain, sell and convey unto Robert Carr and Jennifer Carr (herein referred to as GRANTEE, whether one or more) as joint tenants with right of survivorship, the following described real estate situated in Shelby County, Alabama, to-wit:

The South 1/2 of the NE 1/4 of the SW 1/4 of Section 4, Township 24 North, Range 13 East , Shelby County, Alabama. Excepting highway right of way. Situated in Shelby County, Alabama.

SUBJECT TO: (1) Ad valorem taxes for current and subsequent years, (2) easements, restrictions reservations, rights-of-way, limitations, covenants and conditions of record, if any, (3) mineral and mining rights not owned by the Grantor, if any.

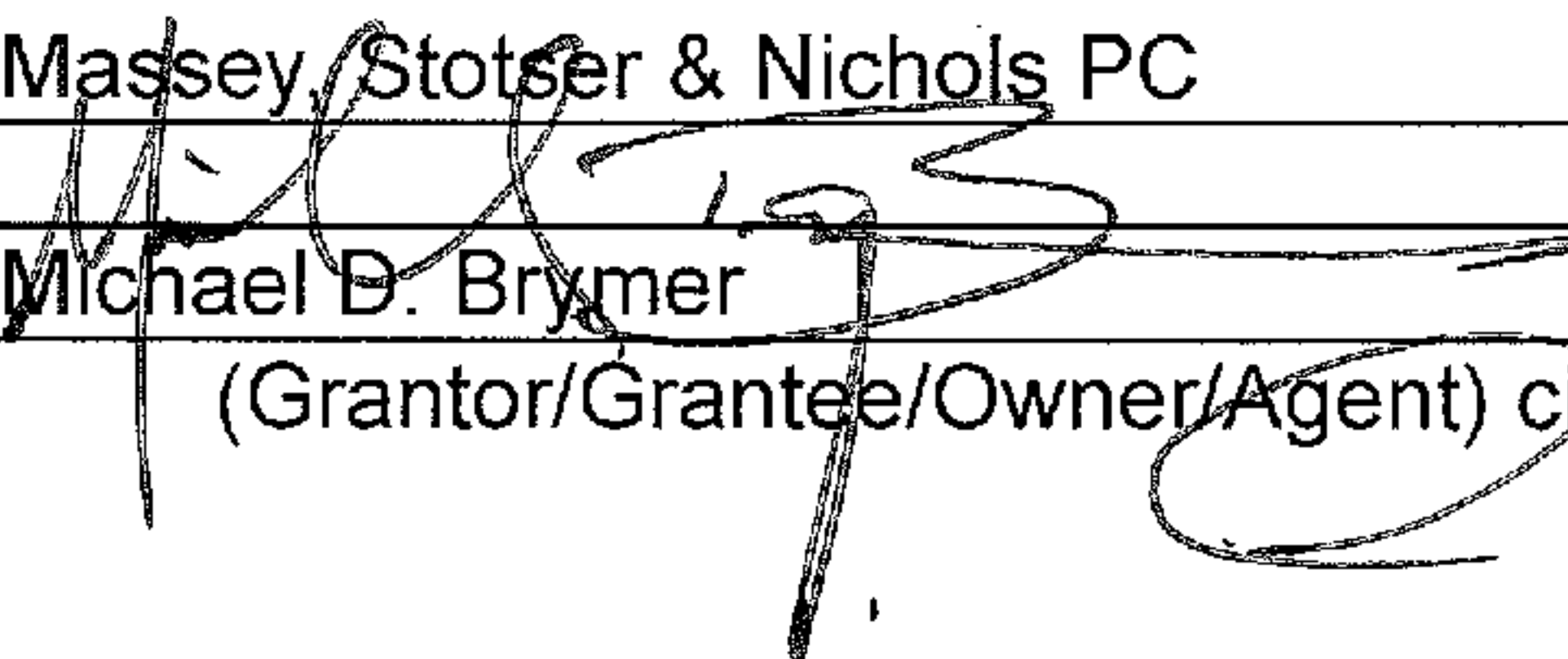

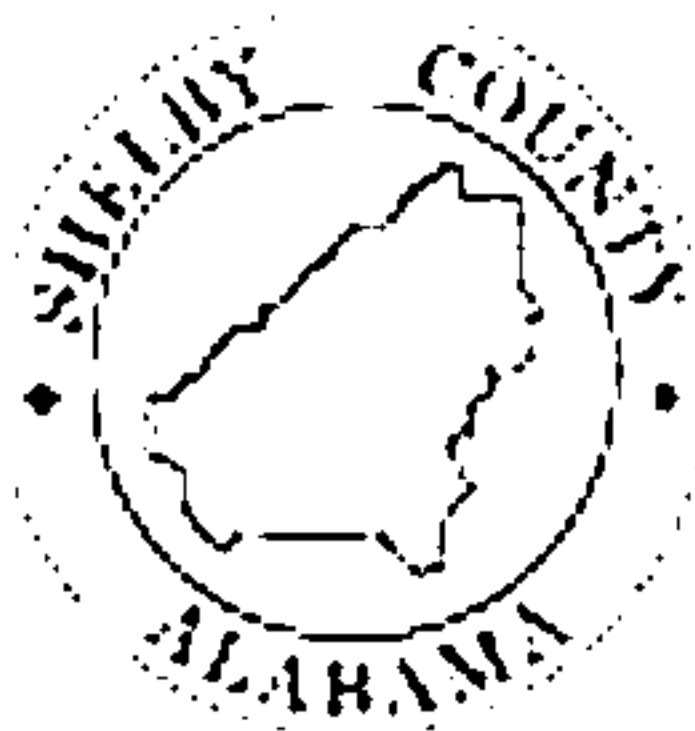
