\$150,505.00 of the above mentioned purchase price was paid for from a mortgage loan which was closed simultaneously herewith.

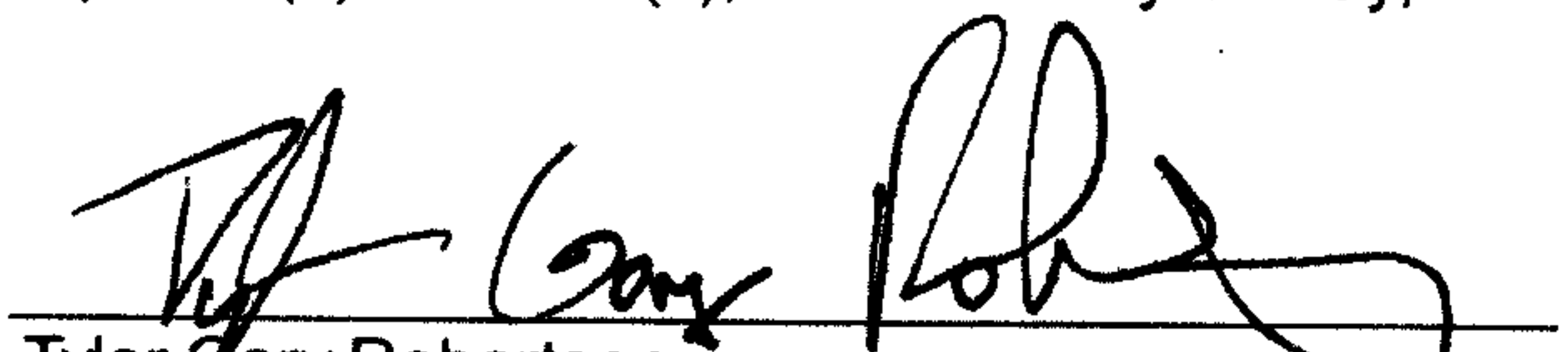

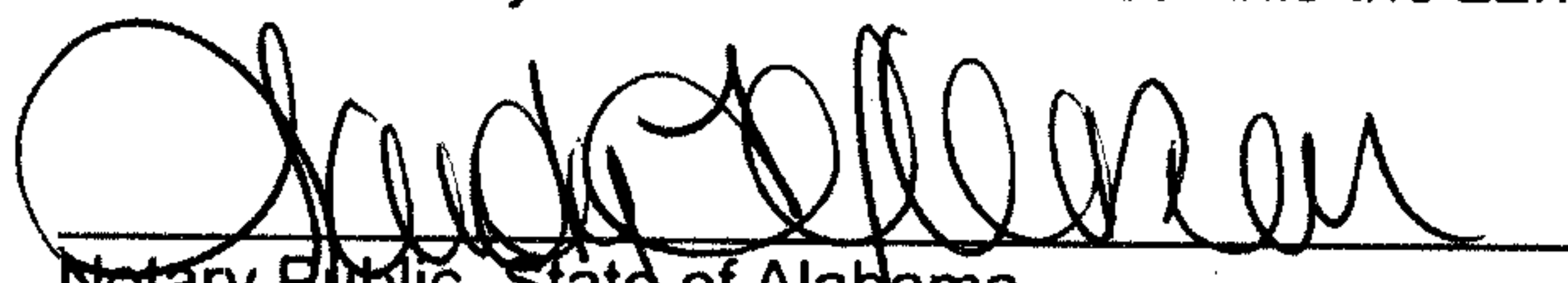
