For ad valorem tax purposes only, the address to the above described property is 1808 Hamilton Road, Pelham, AL 35124.



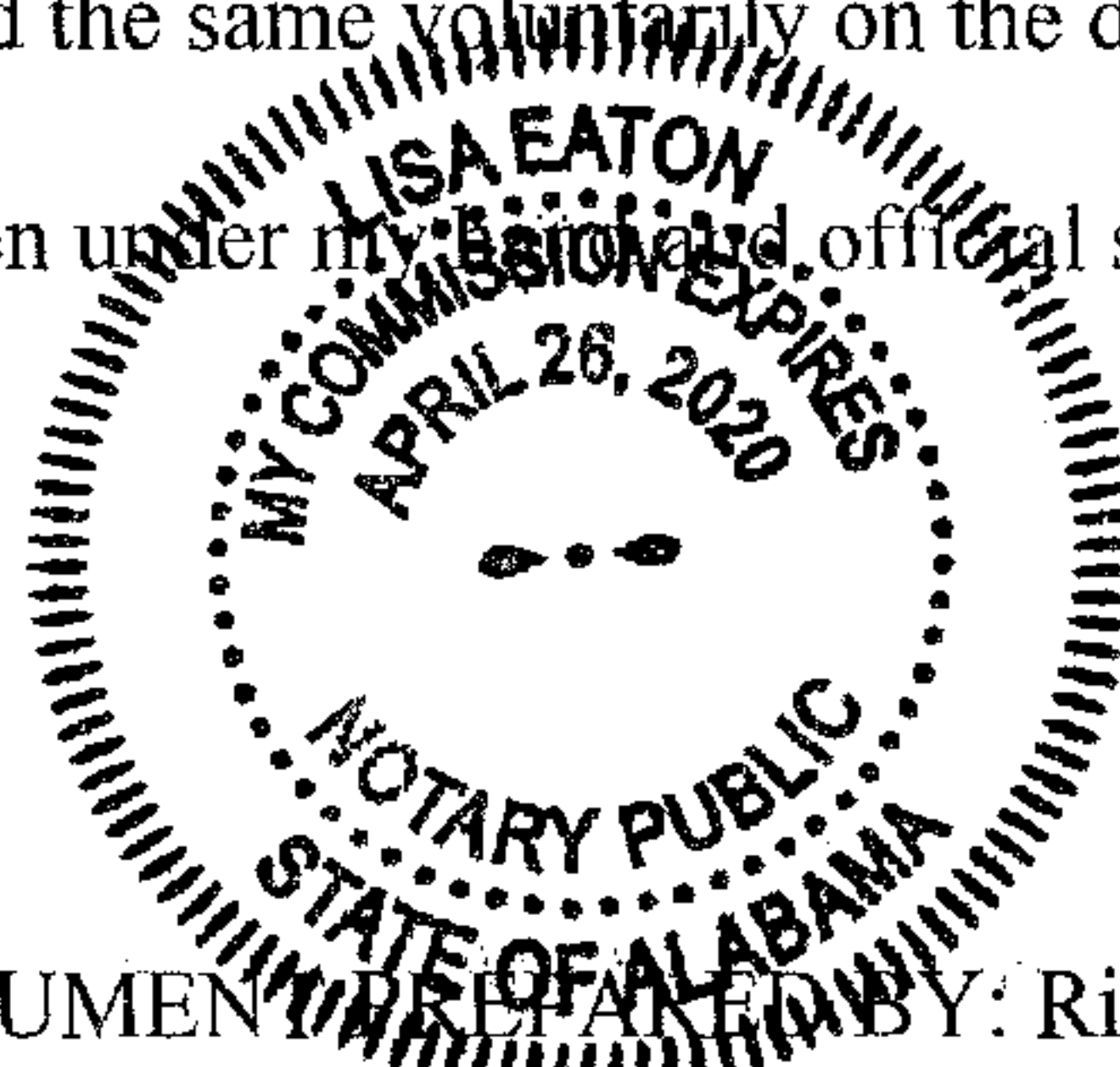


