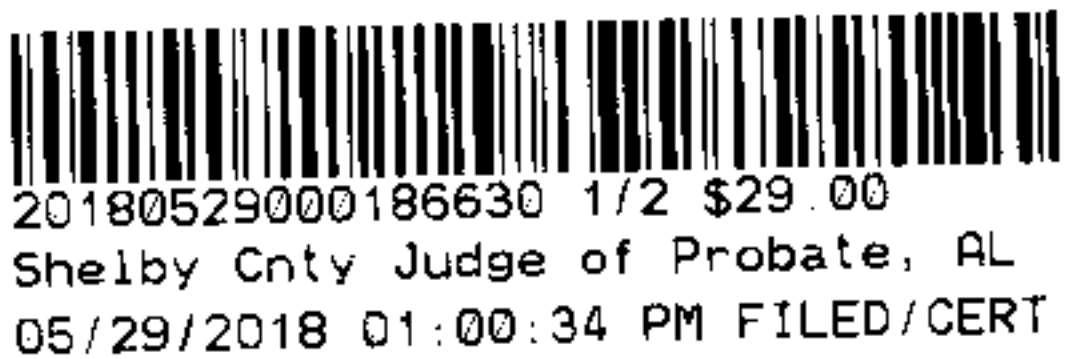

That in consideration of TEN THOUSAND DOLLARS AND OTHER GOOD AND VALUABLE CONSIDERATION to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt whereof is acknowledged, For we,

RONALD W. CLIFTON AND WIFE, TERESA M. CLIFTON

(herein referred to as Grantor, whether one or more), grant, bargain, sell, and convey unto

RONALD W. CLIFTON AND TERESA M. CLIFTON, TRUSTEES, OR THEIR SUCCESSORS IN TRUST, UNDER THE CLIFTON LIVING TRUST, DATED MAY 23, 2018 AND ANY AMENDMENTS THERETO.

(herein referred to as Grantee, whether one or more), the following described real estate, situated in shelby County, Alabama, to-wit:

Lot 9, in Block 12, according to the Survey of Broken Bow South, as recorded in Map Book 11, Page 82, in the Probate Office of Shelby County, Alabama; being situated in Shelby County, Alabama. Mineral and mining rights excepted.

And I (we) do for myself (ourselves) and for my (our) heirs, executors, and administrators covenant with the said GRANTEE, his, her or their successors and assigns, that I am (we are) lawfully seized in fee simple of said premises; that they are free from all encumbrances, unless otherwise noted above; that I (we) have a good right to sell and convey the same as aforesaid; that I (we) will and my (our) heirs, executors and administrators shall warrant and defend the same to the said GRANTEE, his, her or their successors and assigns forever, against the lawful claims of all persons.

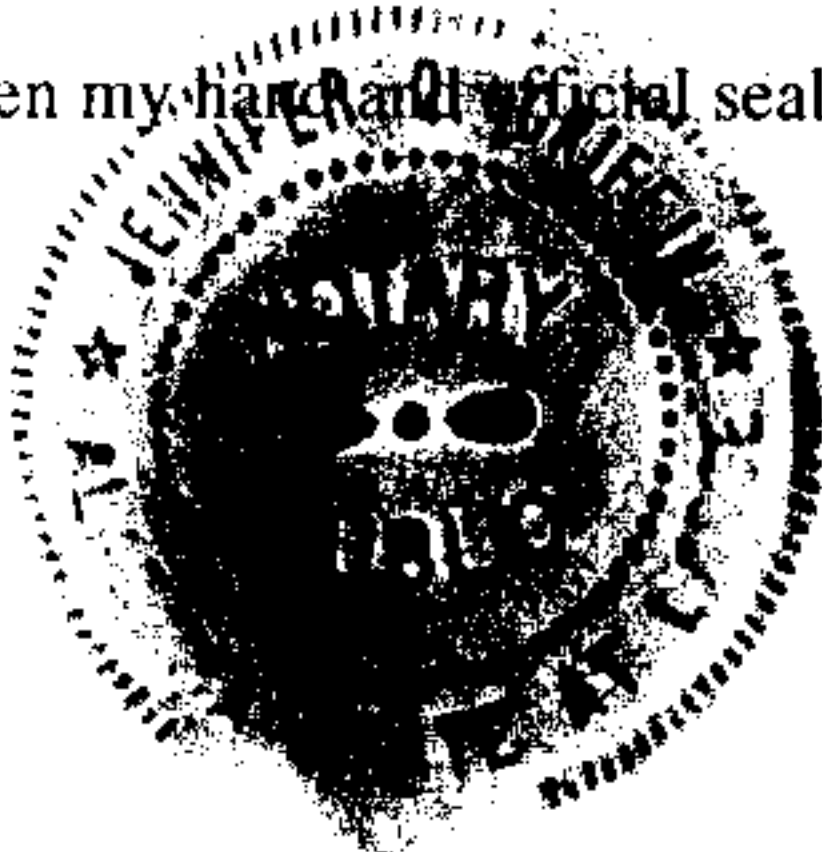

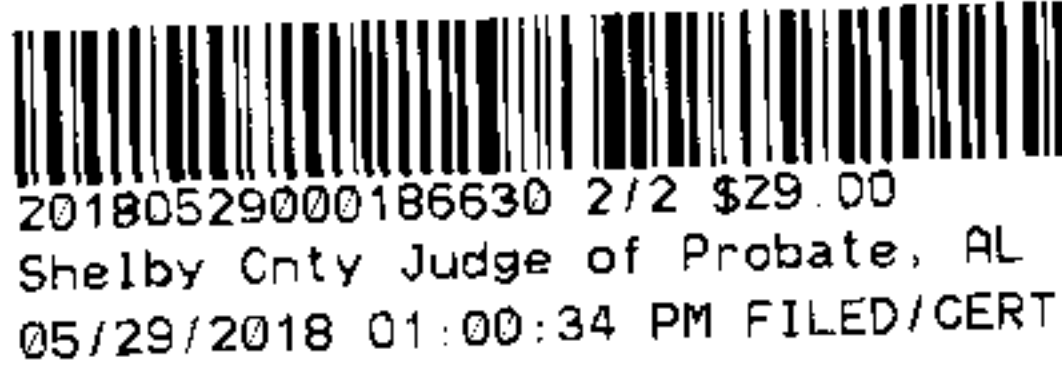
