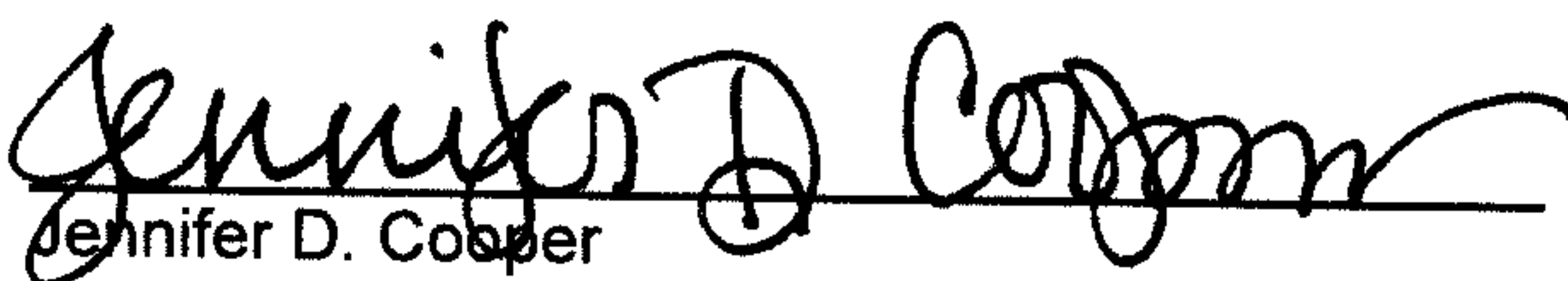

TO HAVE AND TO HOLD to the said grantee, his, her or their heirs and assigns forever.

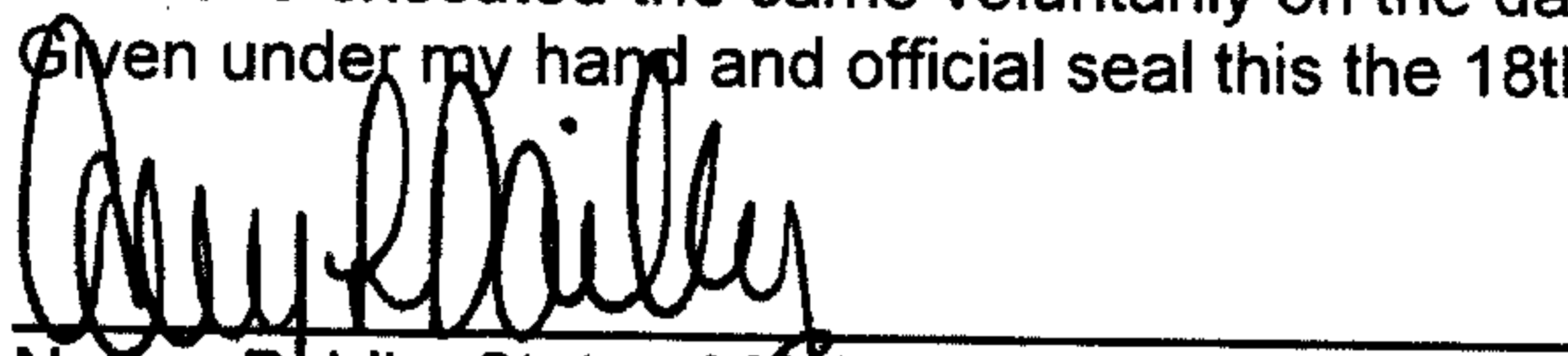
