Lot 1, according to the Survey of Wildwood Estates, as recorded in Map Book 15, Page 15, in the Probate Office of Shelby County, Alabama.




\$437,000.00 of the purchase price of the above described property was financed with the proceeds of a mortgage loan closed simultaneously herewith.



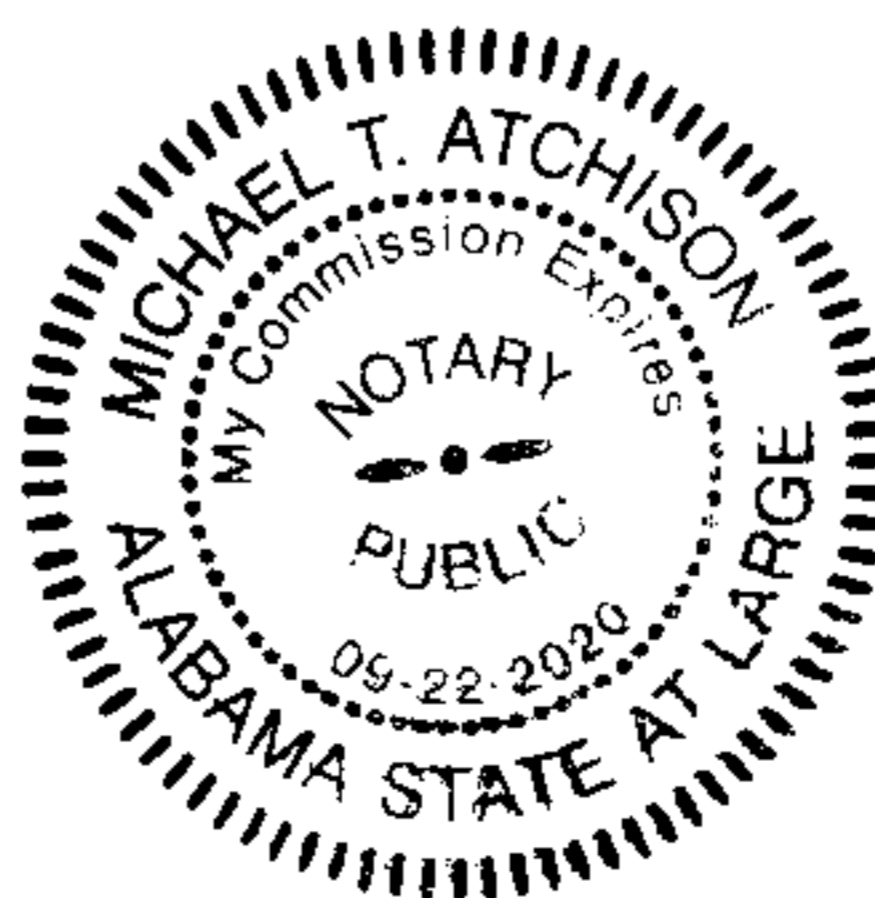
