Subject to current taxes and all covenants, conditions, restrictions, easements and mortgages of record.


\$220,924.00 of the purchase price was paid from the proceeds of a mortgage loan closed simultaneously herewith.



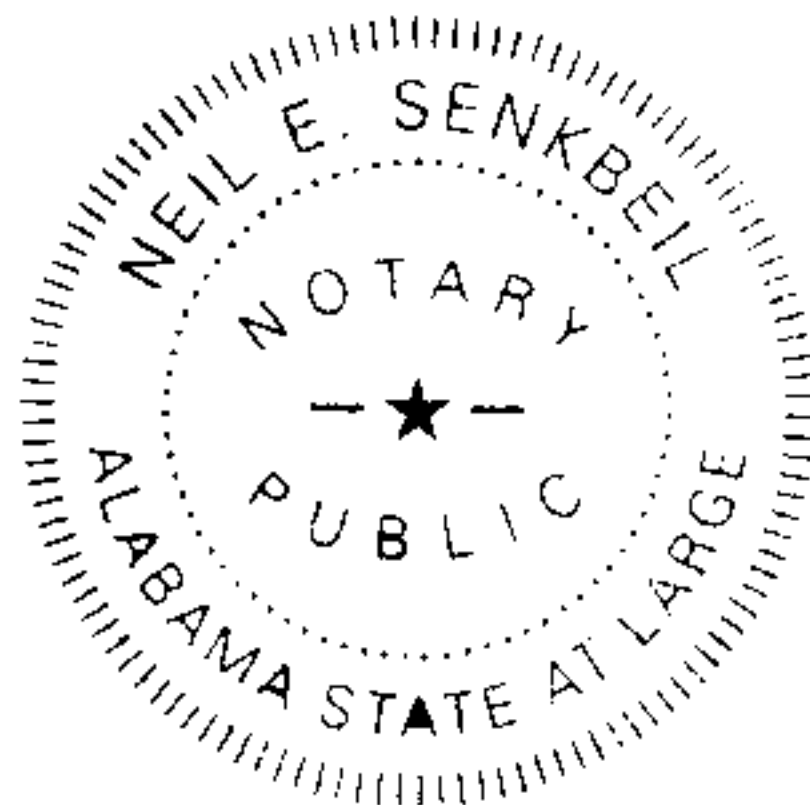
