2. Easements, restrictions, reservations and conditions of record.

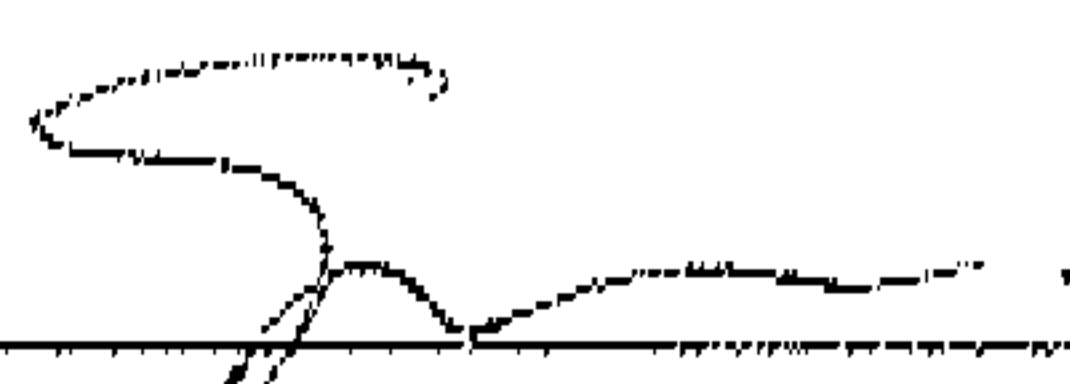
\$360,000.00 of the purchase price was paid from the proceeds of a refinance mortgage closed simultaneously herewith.

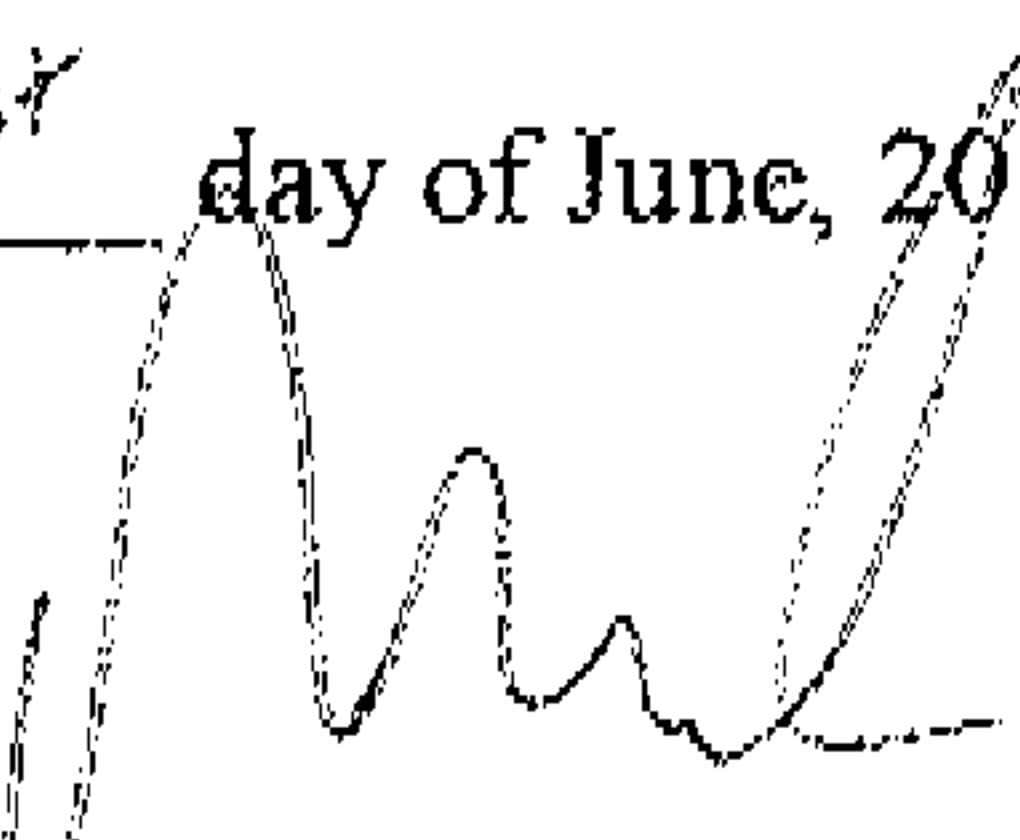

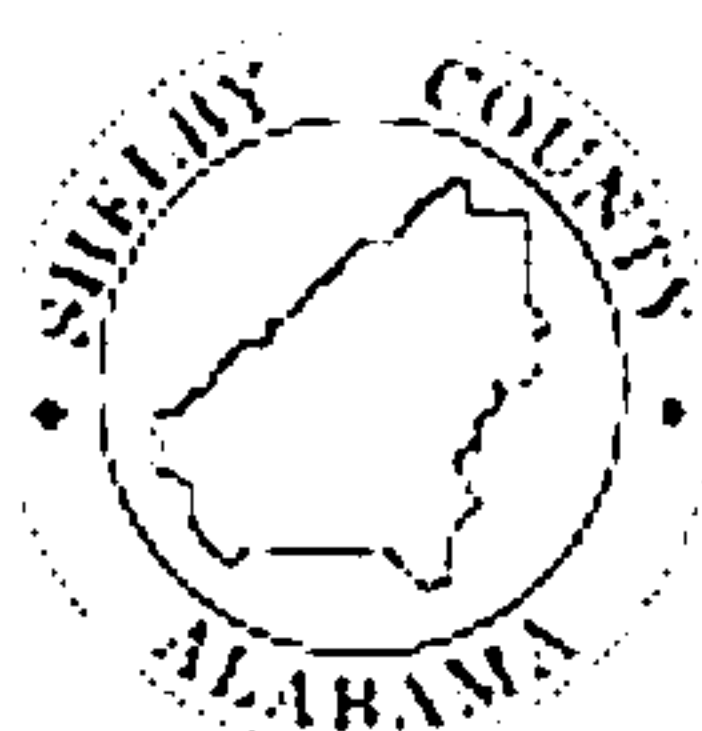
