That in consideration of the sum of **Ninety Thousand Dollars and No Cents (\$90,000.00)**, the amount of which can be verified in the Sales Contract between the parties hereto, to the undersigned Grantor (whether one or more), in hand paid by the Grantee herein, the receipt whereof is acknowledged, I or we, **Curtis Largin and Mary Largin, husband and wife** (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **James Edward Dunn and Tracey Lynn Dunn**, (herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby, County, Alabama, to wit;

Lot 14, according to the Survey of Wilson's Glen, 1st Sector, as recorded in Map Book 27, Page 47, in the Probate Office of Shelby County, Alabama.




\$90,900.00 of the purchase price of the above described property was financed with the proceeds of a mortgage loan closed simultaneously herewith.


