We, the undersigned Trustees, declare as follows:

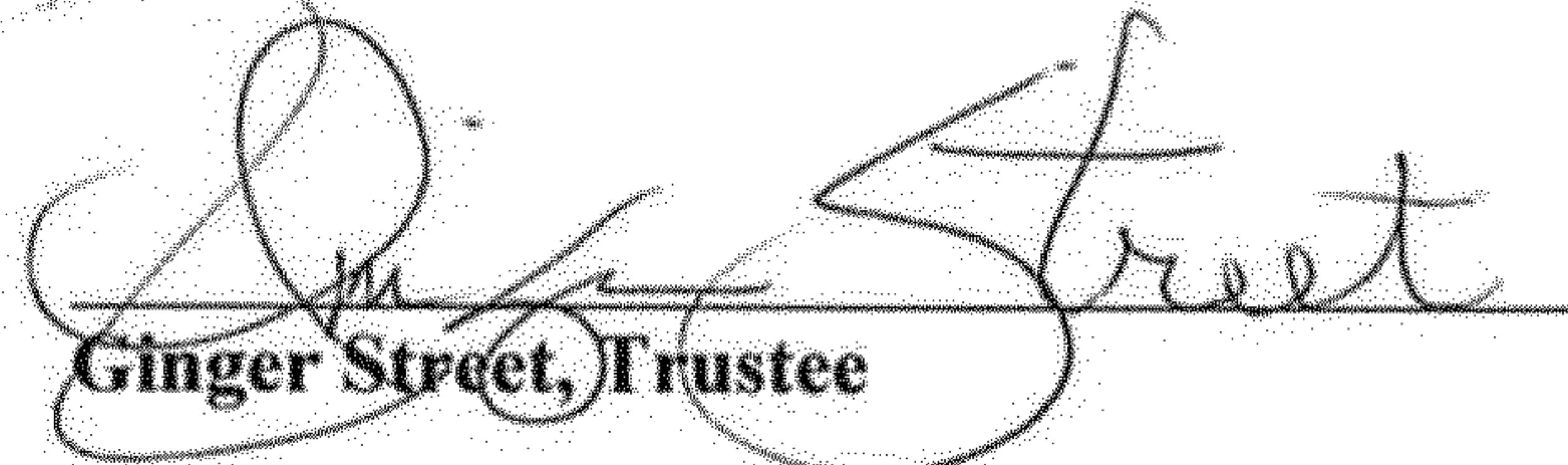
1. The name of the trust is: Birdwell Irrevocable Trust.

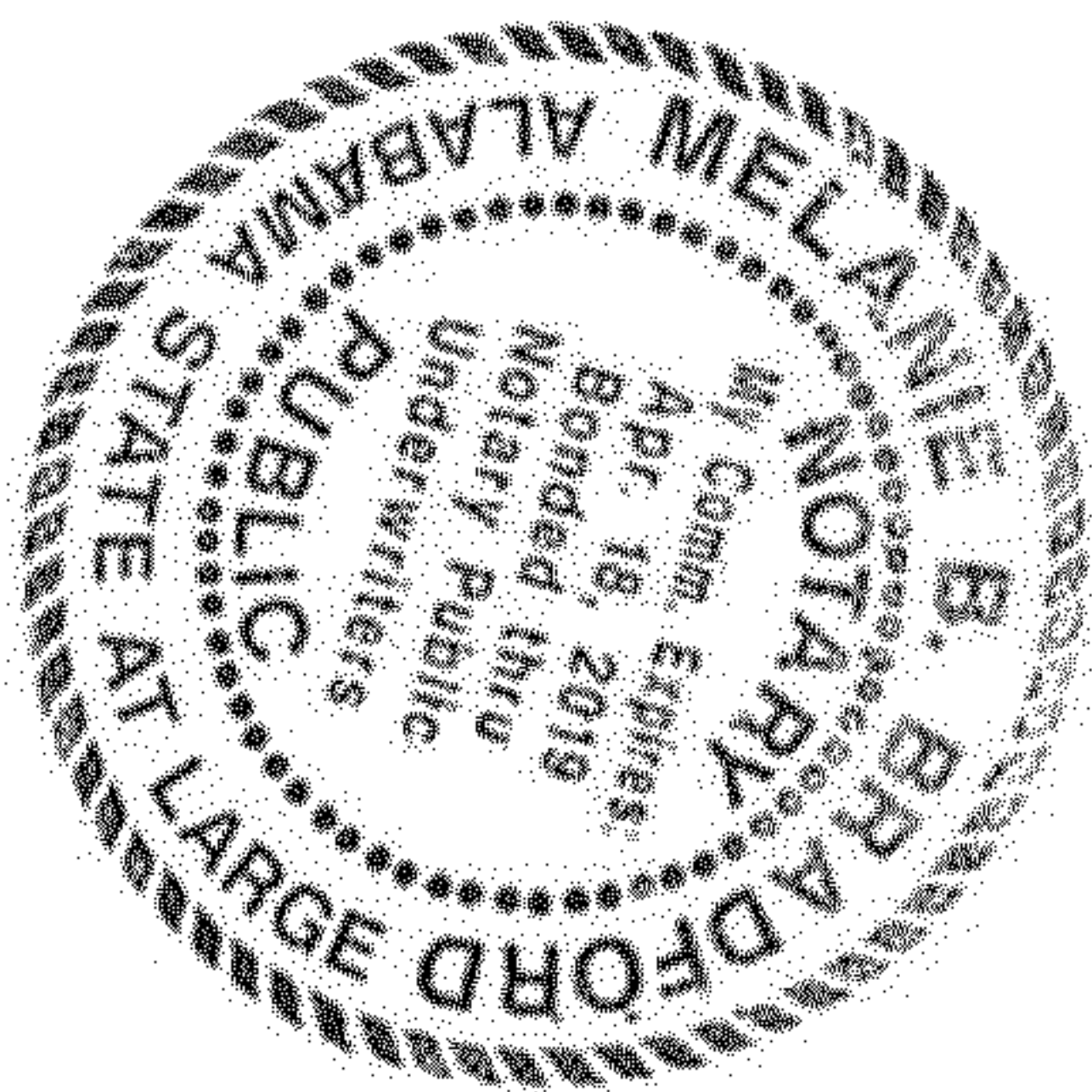

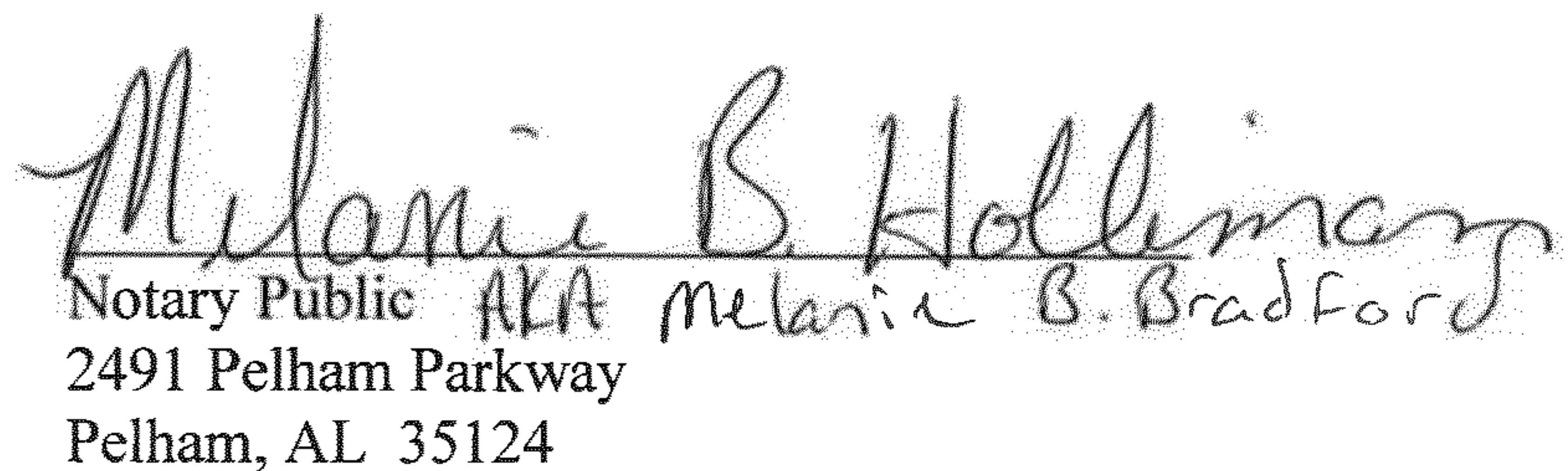
