KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 7th day of September, 2011, Battise J. Greene Sr and Jamila D. Greene, husband and wife, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., as a nominee for DHI Mortgage Company, Ltd., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20110909000268000; having been modified by Loan Modification Agreement recorded in Instrument Number 20140804000241160, said mortgage having subsequently been transferred and assigned to Wells Fargo Bank, N.A., by instrument recorded in Instrument No. 20130114000018320, in the aforesaid Probate Office ("Transferee"); and

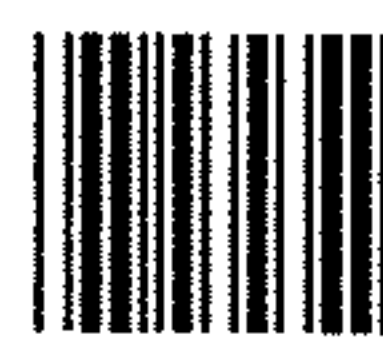
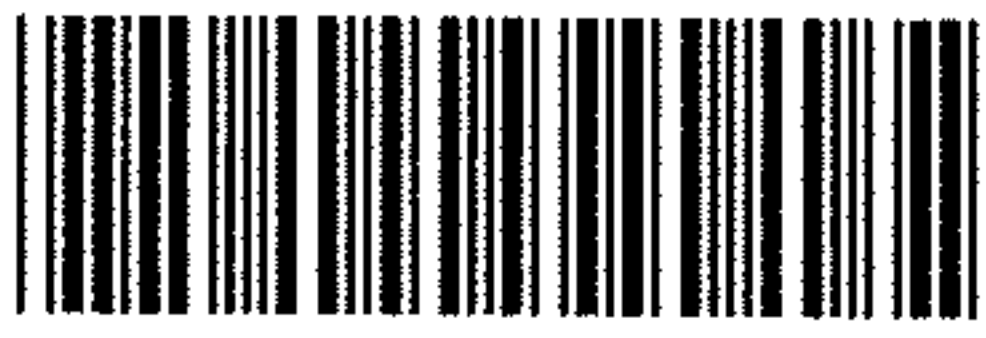
