GARNER, husband and wife** (herein referred to as Grantors) grant, bargain, sell and convey unto **STEVEN EUGENE REEVES and MAUREEN SLOAN** (herein referred to as Grantees), the following described real estate, situated in **SHELBY** County, Alabama, to-wit:
