THAT IN CONSIDERATION OF **Three Hundred Fifteen Thousand Dollars and NO/100 (\$315,000.00)** to the undersigned grantor, in hand paid by the Grantees herein, the receipt whereof is acknowledged, I, **Mary Ridinger, a single person**, (herein referred to as **Grantor**), grant, sell, bargain and convey unto, **George J. Mackinaw, Jr. and Amanda M. Mackinaw** (herein referred to as **Grantee** whether one or more), for and during their joint lives as joint tenants with rights of survivorship and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder or right of reversion, the following described real estate, situated in **SHELBY** County, Alabama to wit:

Lot 59A, according to the Survey of Bent River Phase IV Resurvey #1, as recorded in Map Book 42, Page 41 A & B, in the Probate Office of Shelby County, Alabama.


