Buchsbaum, a married man** (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **Lamont D. Beverly and Shunita L. 

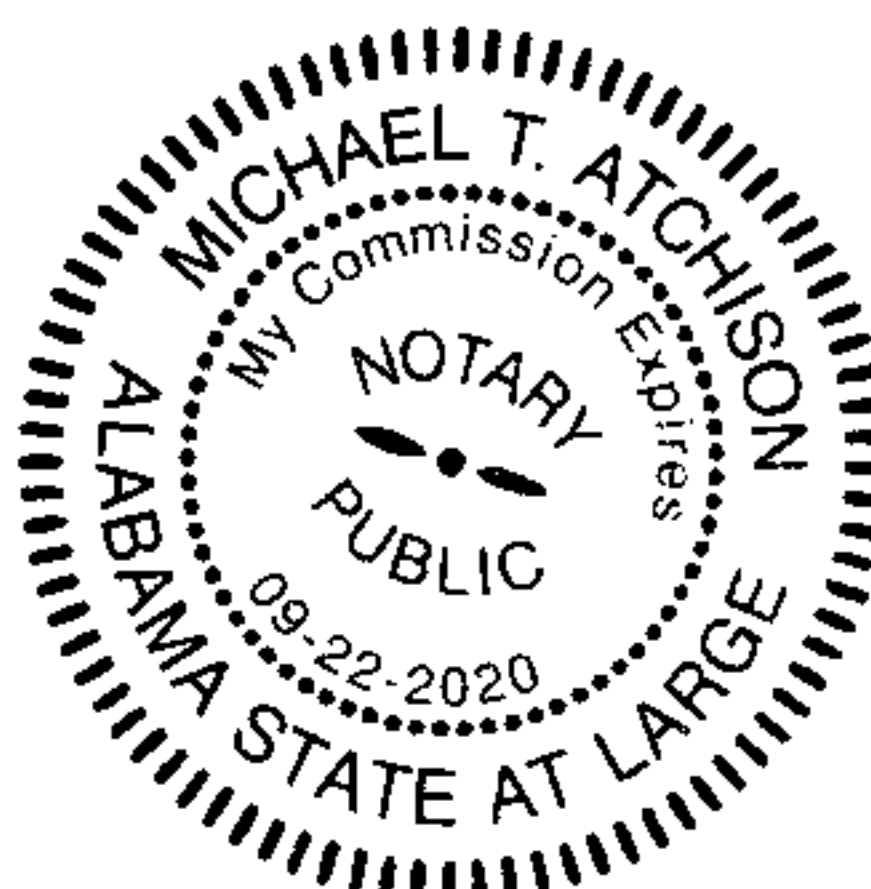
