**CERTIFICATION OF TRUST

1. The McMurray L. Griffith Irrevocable Trust is a valid, existing trust, having been created by the indenture of trust on March 24, 2015.

 - A. The original settlor(s) and successor settlor(s), if any, of the trust is McMurray L. Griffith.
 - B. The following person(s) contributed money, funds, real property, or personal property to the trust: McMurray L. Griffith
 - C. McMurray L. Griffith: deceased on or about September 6, 2017
 - D. The name and address of the currently acting trustee(s) is (are) Maizie Griffith Nelson and Robert David Griffith.
 - E. The named successor trustee(s) is (are) Jodie Griffith Day and John McMurray Griffith.
3. The McMurray L. Griffith Irrevocable Trust has a definite beneficiary. The same person is not the sole trustee and sole beneficiary.

The administrative and/or managerial powers of the trustee are general trustee powers under Alabama law, including, but not limited to, the power to sell, pledge, mortgage, transfer, convert or otherwise dispose of, or grant any of the property of the trusts....and to texecute and deliver any mortgages, deed or deeds (with or without warranty)...in connection with any of his [or her] powers.
5. The trust is irrevocable.

 - A. The following trustees have the authority to sign documents and instruments: Maizie Griffith Nelson and Robert David Griffith, co-trustees.
 - B. Maizie Griffith Nelson and Robert David Griffith, co-trustees must execute documents jointly unless otherwise agreed upon in writing.

7. Third parties are entitled to rely on the authority of the successor trustee(s) without proof of his/her/their succession.
8. The social security number/employer identification number assigned to the trust is: 381.
