SUPPLEMENT TO MORTGAGE

This Supplement to Mortgage (this "Supplement") is entered into as of July 6, 201 8, by and among LAKE WILBORN PARTNERS, LLC, an Alabama limited liability company ("Lake Wilborn"), BLACKRIDGE PARTNERS, LLC, an Alabama limited liability company ("Blackridge Partners" together with Lake Wilborn, individually or collectively, the "Mortgagor") in favor of WELLS FARGO BANK, NATIONAL ASSOCIATION, a national banking association ("Lender").

Agreement (the "Modification Agreement") dated December 31, 2017, as amended by Second Modification Agreement (the "Second Modification Agreement") dated May 3, 2018 (as modified, amended or restated, the "Credit Agreement"), (ii) that certain Fifth Amended and Restated Promissory Note Secured by Mortgage dated effective December 28, 2017 executed by Borrower in favor of Lender, as modified by the Modification Agreement and Second Modification Agreement (as modified, amended or restated, the "Note"), and (iii) that certain Mortgage and Security Agreement dated May 9, 2018 from Mortgagor in favor of Lender, recorded as Instrument No. 20180509000159420 in the Office of the Judge of Probate of Shelby County, Alabama (as amended from time to time, the "Mortgage"). Such supplement and amendment shall include, without limitation, all right, title, interest, and privileges of Mortgagor in and to (i) all streets, ways, roads, alleys, easements, rights—of—way, licenses, rights of ingress and egress, vehicle parking and public places, existing or proposed, abutting, adjacent, used in conjunction with or pertaining to such real property or the interests therein; (ii) any strips or gores of real property between such real property and abutting or adjacent properties; (iii) all water and water rights, timber and crops pertaining to such real estate; and (iv) all appurtenances and all reversions and remainders in or to such real property (all collectively referred to herein as the "Added Land"), and all other Mortgaged Property (after giving effect to the addition of the property described in Exhibit A to the definition of Land). Mortgagor hereby grants, bargains, sells, conveys, mortgages and assigns the Added Land and other Mortgaged Property to Lender, subject to the terms and conditions of the Mortgage.

<u>Continued Effectiveness of Documents</u>. In all other respects the Mortgage shall remain unchanged and in full force and effect, and Mortgagor affirms that it has no offsets or defenses to its obligations pursuant to the Mortgage or other documents secured thereby or executed in connection therewith.


