Lot 44, according to the Survey of Fairview, as recorded in Map Book 22, Page 135, in the Probate Office of Shelby County, Alabama.


Subject to rights-of-way, covenants, restrictions, easements, agreements, setback lines, reservations, mineral/mining rights, and declarations of record, if any.


\$130,591.00 of the above-recited purchase price is being paid with a purchase money mortgage being recorded simultaneously herewith.


