WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP

That in consideration of **One Hundred Forty Two Thousand and 00/100 Dollars (\$142,000.00)** to the undersigned grantor in hand paid by the grantees herein, the receipt whereof is acknowledged, I,

(hereinafter referred to as "Grantor") do grant, bargain, sell and convey unto

(hereinafter referred to as "Grantees") as joint tenants with right of survivorship, the following described real estate situated in **Shelby County, Alabama** to-wit:

(3) all easements, rights-of-way, restrictions, covenants and encumbrances of record.


