Know All Men by These Presents: That in consideration of **Three Hundred Sixty-Four Thousand Three Hundred Twenty-Eight and no/100 Dollars (\$364,328.00)**, to the undersigned Grantor, in hand paid by the Grantees herein, the receipt where is acknowledged, **DONOVAN BUILDERS, LLC** (herein referred to as Grantor), grant, bargain, sell and convey unto **DAVID R.
