**ARTICLE I
NAME**

ARTICLE VI ADDITIONAL MEMBERS

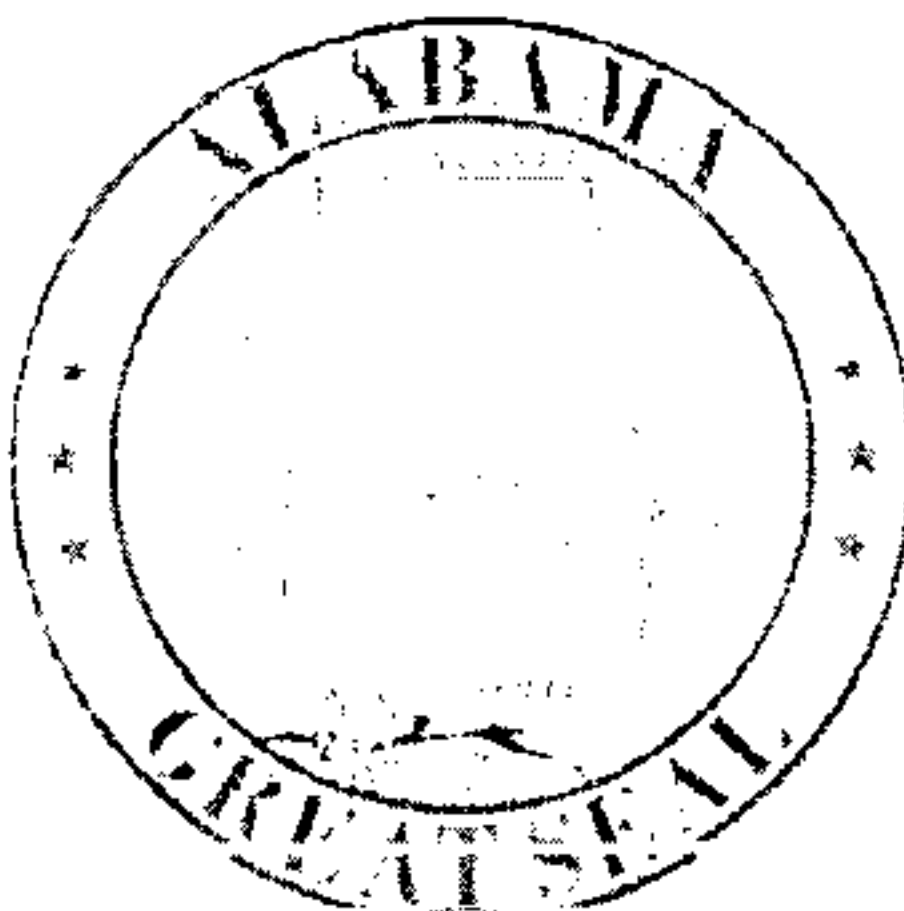
