Know All Men by These Presents: That in consideration of **Two Hundred Thirteen Thousand and no/100 Dollars (\$213,000.00)**, to the undersigned Grantors, in hand paid by the Grantees herein, the receipt where is acknowledged, we, **SEAN PRICE and JESSICA PRICE, husband and wife** (herein referred to as Grantors) grant, bargain, sell and convey unto **STAVROS LEWIS and CHRISTINA LEWIS** (herein referred to as Grantees), the following described real estate, situated in **SHELBY** County, Alabama, to-wit:

To Have and to Hold to the said Grantees, as joint tenants, with right of survivorship, their heirs and assigns forever; it being the intention of the parties to this conveyance, that (unless the joint tenancy created is severed or terminated during the joint lives of the grantees herein) in the event one Grantee herein survives the other, the entire interest in fee simple shall pass to the surviving Grantee, and, if one does not survive the other, then the heirs and assigns of the Grantees herein shall take as tenants in common.

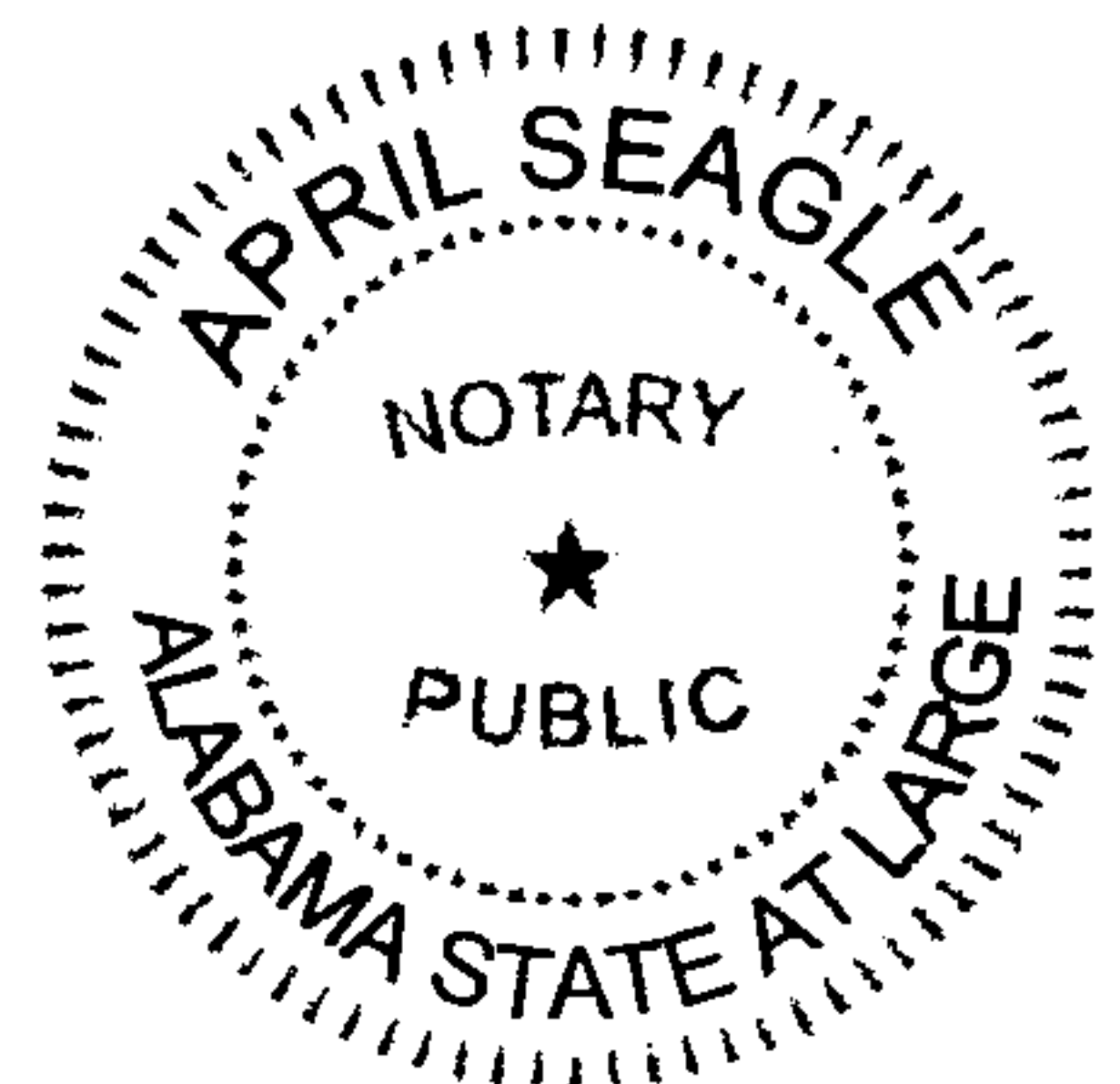

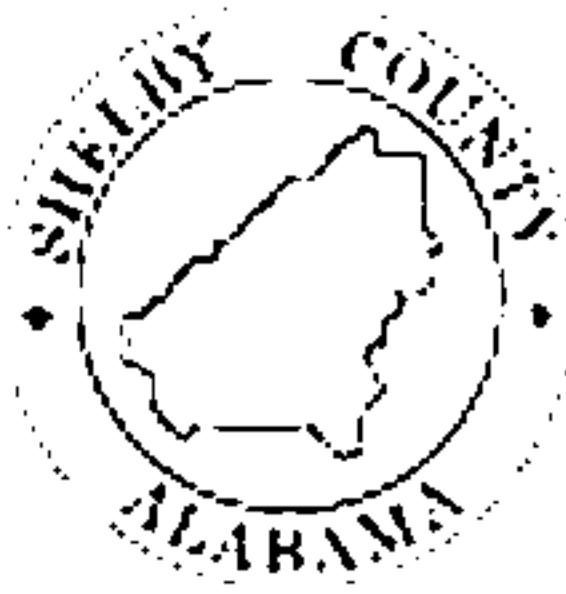
