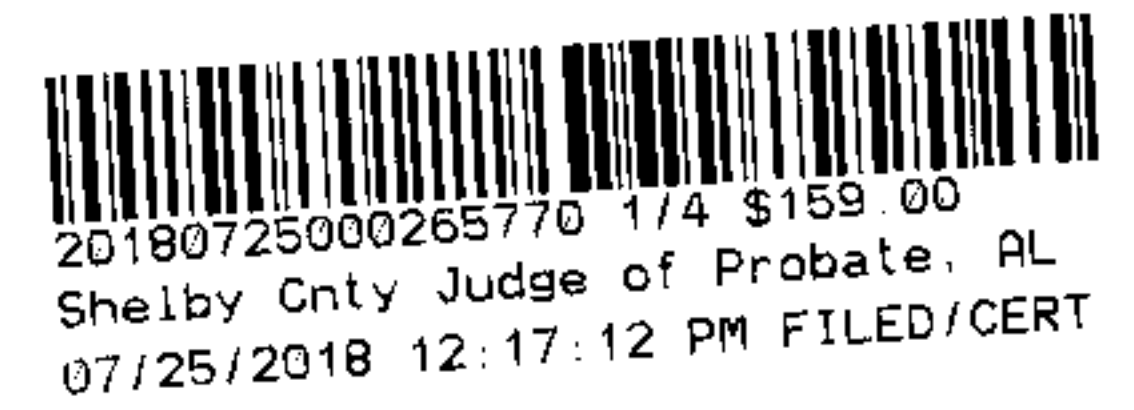


**TO THE HONORABLE SHELBY COUNTY PROBATE JUDGE**

**ARTICLES OF ORGANIZATION  
OF  
PARAGON ENTERPRIZES, LLC**



The undersigned pursuant to the provision of the Alabama Limited Liability Company Act, Section 10-12-1 et. Seq CODE OF ALABAMA, (1975), as amended from time to time, for the purpose of forming a Limited Liability Company under the laws of the State of Alabama hereby adopts the following Articles of Organization:

**ARTICLE I  
NAME**

The name of the Limited Liability Company is PARAGON ENTERPRIZES, LLC, which is hereinafter referred to as "the Company."

**ARTICLE II  
Period of Duration**

The period of duration of the Company shall be from the date of filing until dissolution of the Company pursuant to provisions of either the Alabama Limited Liability Company Act (the "ACT") of the Company Operating Agreement which may hereafter be lawfully ratified and which is in effect at that time.

**ARTICLE III  
Purpose**

The purposes for which this Company is formed are to do any and all things hereafter set forth, to the same extent as natural persons in any part of the world, namely:

- (a) Principal Purpose** – To provide fashionable clothes or accessories services
- (b) Ancillary Purpose** – To do everything necessary, proper, advisable, or convenient for the accomplishment of the foregoing purposes, and to do all other things incidental to them or connected with them that are permitted or not forbidden by the Alabama Limited Liability Company Act, by other law or by these Articles of Organization.

**ARTICLE IV**

**Address of Initial Registered Office  
And Name of Initial Registered Agent at that Address**

The location and street address of the initial registered office of the Company shall be 116 Saintfield Lane, Birmingham, Alabama 35242, and the initial registered agent at such address shall be Talittla Eubanks Smith.

**ARTICLE V  
Initial Members, Offices Held and Number of Voting Shares**

The names, offices held, voting shares and mailing address of the initial members of the Company are:

**ARTICLE VI  
Additional Members**

Upon the unanimous written consent of the member(s), addition members may be admitted, and the terms and conditions of their admission shall be as set forth within such unanimously approved written consent or within Company Operating Agreement which may hereafter be lawfully ratified and which is in effect at that time.

**ARTICLE VII  
Continuation of Business**

The Company may be reconstructed and the business of the Company be continued following an event of dissociation which terminated the membership of the last remaining members of the Company if either (i) the holders of all the financial rights is the Company agree in writing, within ninety days after the cessation of membership of the last member, to continue the legal existence and business of the Company and to appoint one or more new members; of (ii) the legal existence and business of the Company is continued and one or more new members are appointed in the manner stated in any Company Operating Agreement which may hereafter be lawfully ratified and which is in effect at that time.

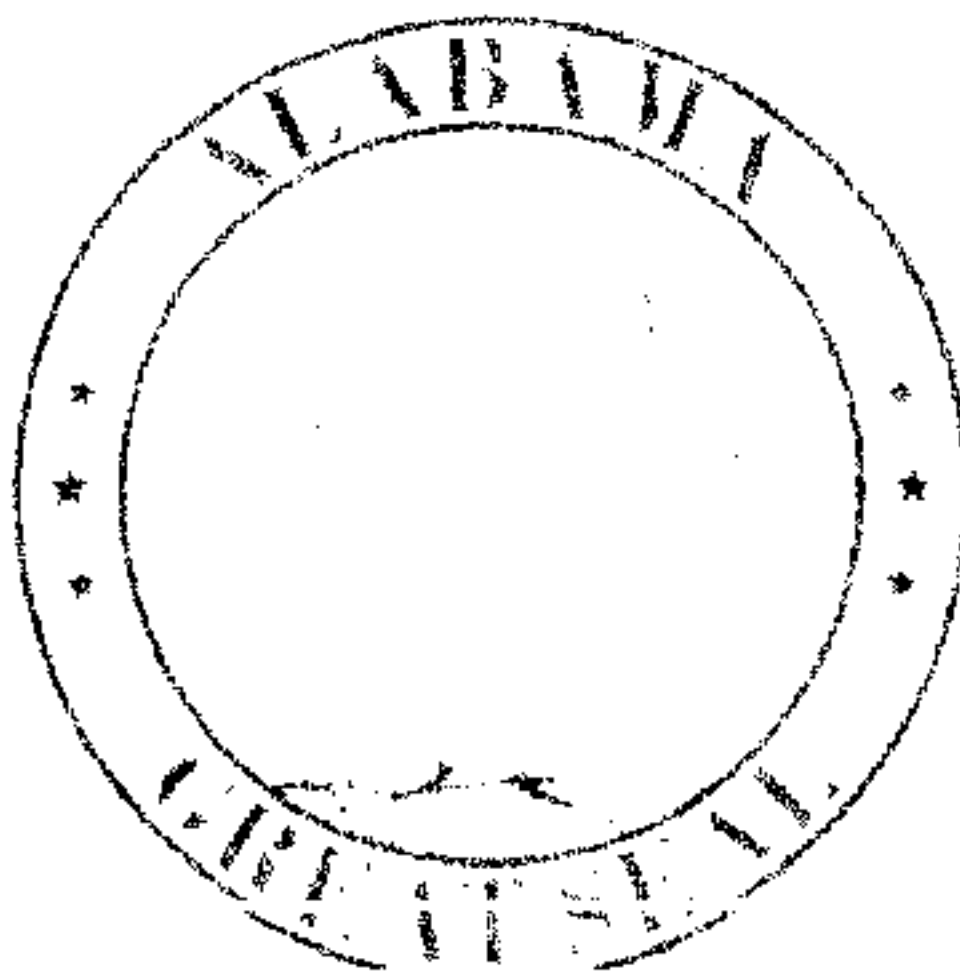
