

CERTIFICATION OF TRUST

In Accordance with North Carolina General Statute Section 36C-10-1013

To Whom It May Concern:

WHEREFORE, North Carolina General Statute Section 36C-10-1013 states in part:

- a. Instead of furnishing a copy of the trust instrument to a person other than a beneficiary, the trustee may furnish to the person a certification of trust....
- b. Any trustee may sign or otherwise authenticate a certification of trust....
- d. A certification of trust need not contain the dispositive terms of the trust....
- f. A person who acts in reliance upon a certification of trust without knowledge that the representations contained in the certification are incorrect is not liable to any person for so acting and may assume without inquiry the existence of the facts contained.
- g. A person who in good faith enters into a transaction in reliance upon a certification of trust may enforce the transaction against the trust property as if the representations contained in the certification were correct.
- h. A person making a demand for the trust instrument in addition to a certification of trust or excerpts is liable for damages if the court determines that the person did not act in good faith in demanding the trust instrument.

NOW THEREFORE, I, BARRY A. WALKER, being first duly sworn, hereby certify the following:

- 1) I am the Trustee of THE BARRY A. WALKER LIVING TRUST, dated September 23, 1997.
