That in consideration of the sum of **Two Hundred Forty Four Thousand Dollars and No Cents (\$244,000.00)**, the amount of which can be verified in the Sales Contract between the parties hereto, to the undersigned Grantor (whether one or more), in hand paid by the Grantee herein, the receipt whereof is acknowledged, I or we, **Benjamin House and Tresa House**, husband and wife (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **Gregory Johnson and Kristen Johnson**, (herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby, County, Alabama, to wit;

Lot 43, according to the Survey of Perkins Landing, Sectors 1 and 2, as recorded in Map Book 27, Page 33 and the Resurvey of Lots 14, 15, 28, 29 and Common Area "E" as recorded in Map Book 27, Page 130, in the Probate Office of Shelby County, Alabama; being situated in Shelby County, Alabama.

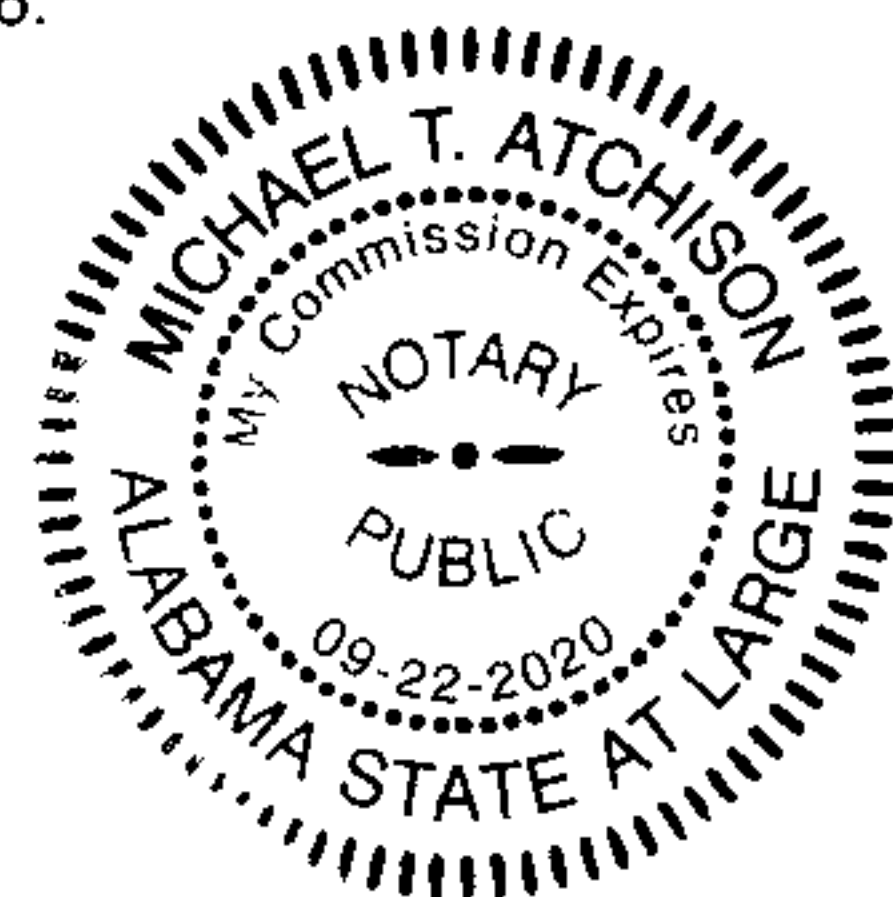
