**GENERAL WARRANTY DEED  
With Right of Survivorship**

STATE OF ALABAMA }

COUNTY OF SHELBY } KNOW ALL MEN BY THESE PRESENTS:

THAT IN CONSIDERATION OF **Four Hundred Forty-Nine Thousand Nine Hundred Dollars and NO/100 (\$449,900.00)** to the undersigned grantor, in hand paid by the Grantee herein, the receipt whereof is acknowledged, we, **David M. Cherry and Autumn Cherry, husband and wife**, (herein referred to as **Grantors**), grant, sell, bargain and convey unto, **Walter Harold Moreland, III, Walter Harold Moreland, Jr., and Shelley W. Moreland** (herein referred to as **Grantee** whether one or more), for and during their joint lives as joint tenants with rights of survivorship and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder or right of reversion, the following described real estate, situated in **SHELBY** County, Alabama to wit:

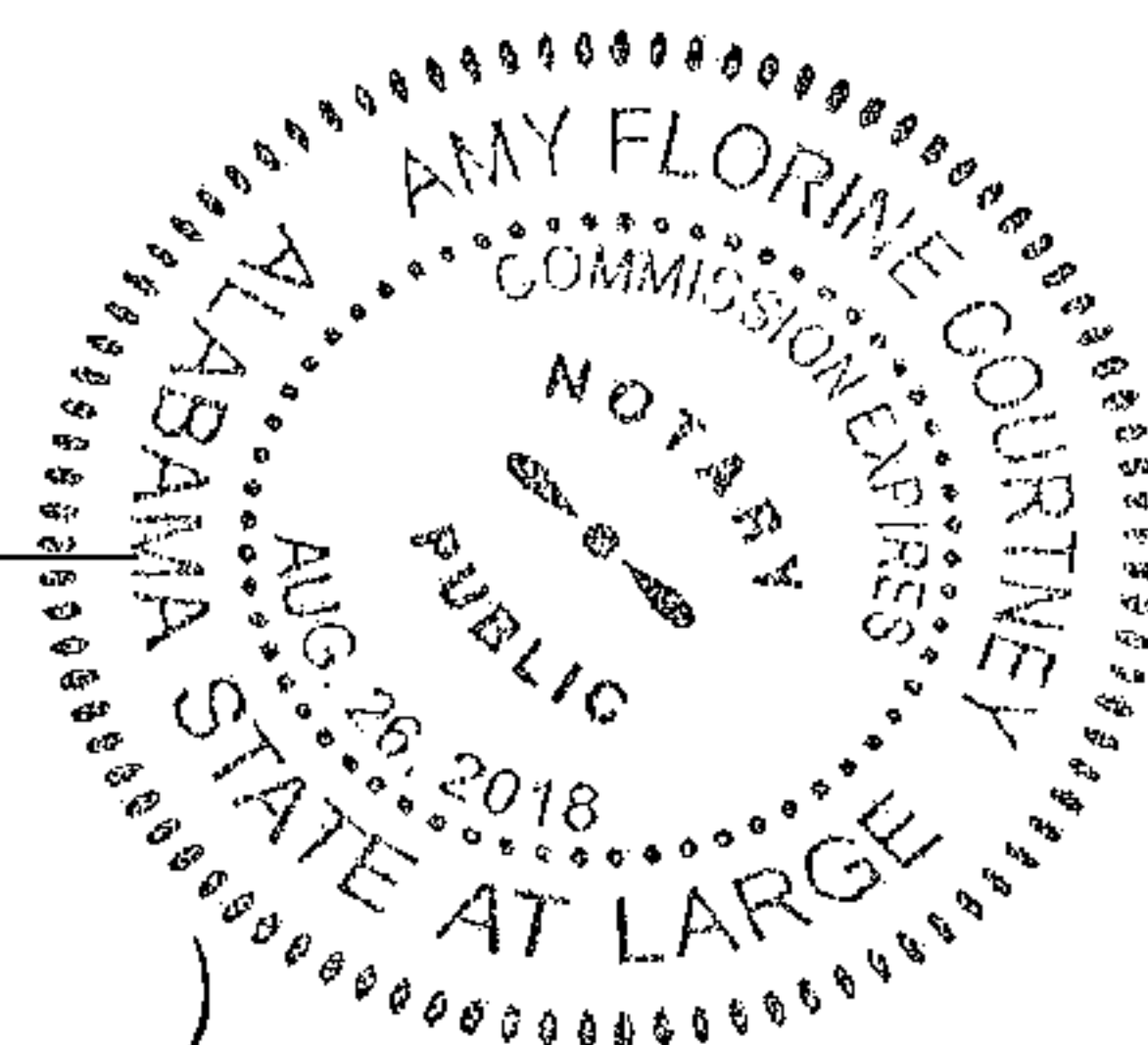

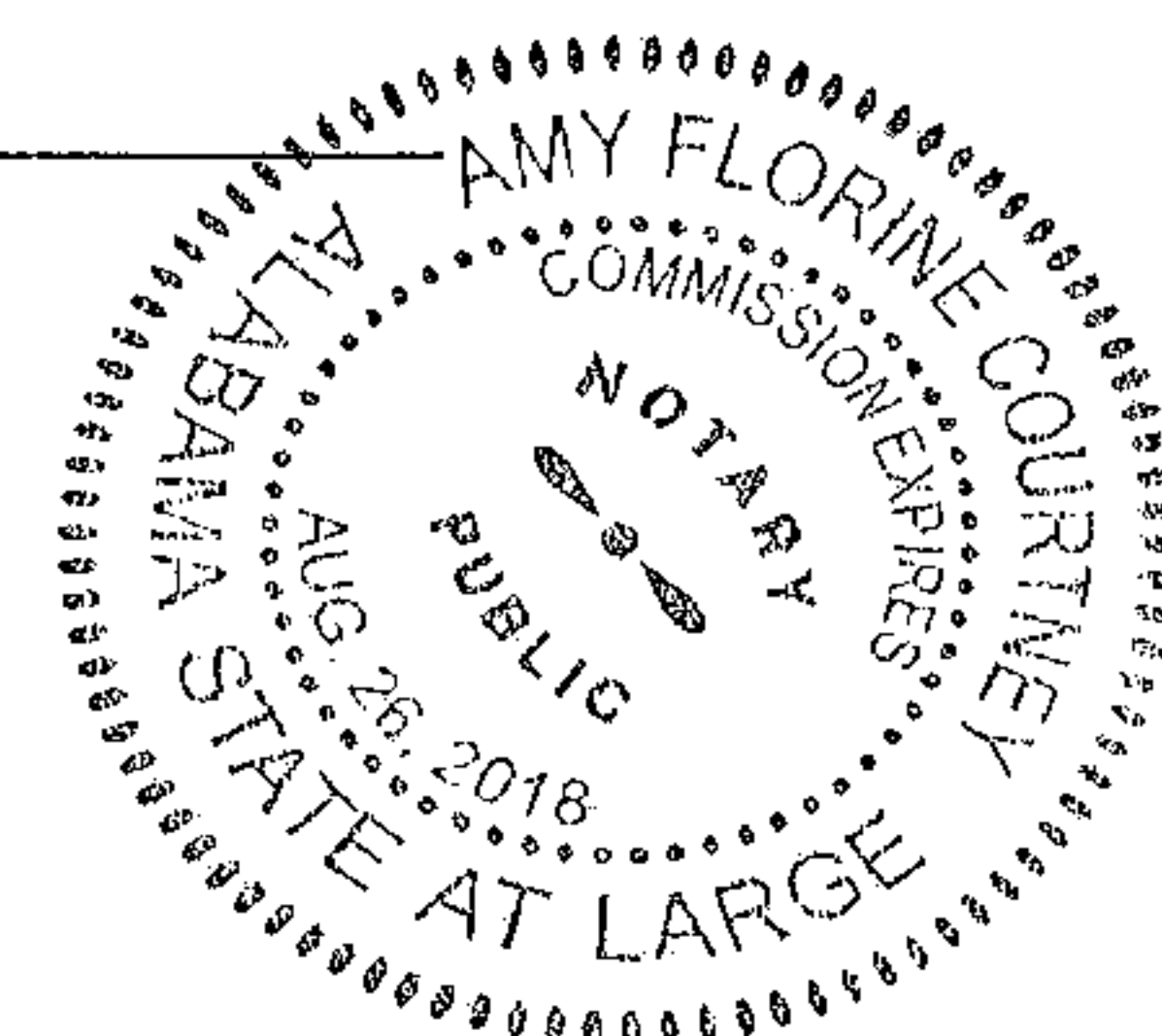
