WARRANTY DEED WITH JOINT RIGHT OF SURVIVORSHIP

**STATE OF ALABAMA
COUNTY OF SHELBY**

KNOW ALL MEN BY THESE PRESENTS,

That for and in consideration of **THREE HUNDRED TEN THOUSAND AND NO/100 (\$310,000.00) DOLLARS**, and other good and valuable consideration, this day in hand paid to the undersigned **GREGORY NEIL GOVE and DONNA W. GOVE**, husband and wife, (herein referred to as "Grantors"), in hand paid by the Grantees herein, the receipt whereof is hereby acknowledged, the Grantors do hereby give, grant, bargain, sell and convey unto the Grantees, **KENNETH M. BUSH and DANA R. BUSH**, (herein referred to as "Grantees"), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, all of the Grantors' interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA**, to wit:

Lot 8, according to the Survey of Meadowbrook 4th Sector, as recorded in Map Book 7, Page 67, in the Probate Office of Shelby County, Alabama.

Subject to:

1. General and special taxes or assessments for the year 2018 and subsequent years not yet due and payable.
2. Municipal improvements, taxes, assessments, and fire district dues against subject property, if any.
3. Mineral and mining rights not owned by Grantors.
4. Any applicable zoning ordinances.
5. Easements, encroachments, building set back lines, rights-of-ways as shown of record by recorded plat or other recorded instrument, including any amendments thereto.
6. All matters, facts, easements, restrictions, assessments, covenants, agreements and all other terms and provisions in Map Book 7, Page 67.
7. 20 foot easement along west lot line as per plat.
8. Building and setback lines of 35 feet as recorded in Map Book 7, Page 67.
9. Subject to Covenants, Conditions and Restrictions as set forth in the Document recorded in Misc. Book 25, Page 299 and Misc. Book 27, Page 890.
10. Right of Way granted to Alabama Power Company as set forth in Deed Book 316, Page 394.
11. Agreement with Alabama Power Company relating to underground residential distribution system as recorded in Misc. Book 27, Page 891, and Misc. Book 48, Page 880.

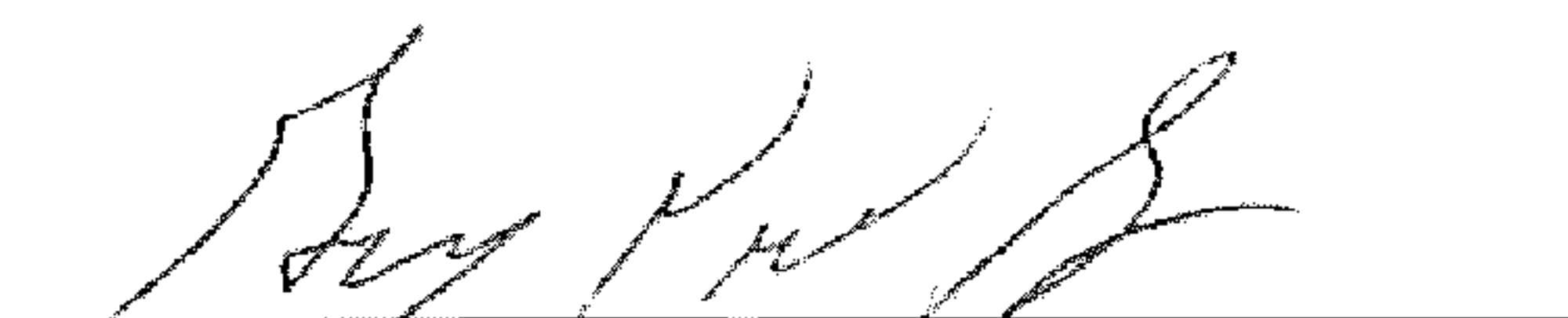
The purchase of the herein described real property is being financed in whole or in part by the proceeds of a purchase money mortgage being executed simultaneously herewith.

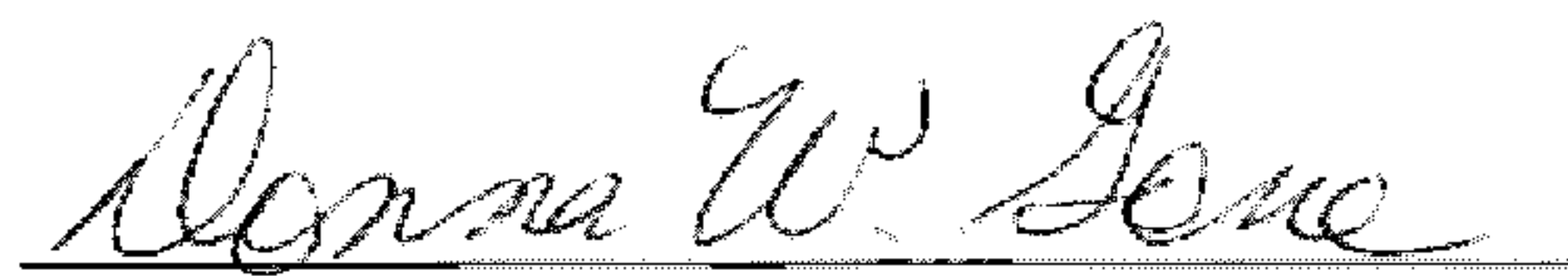

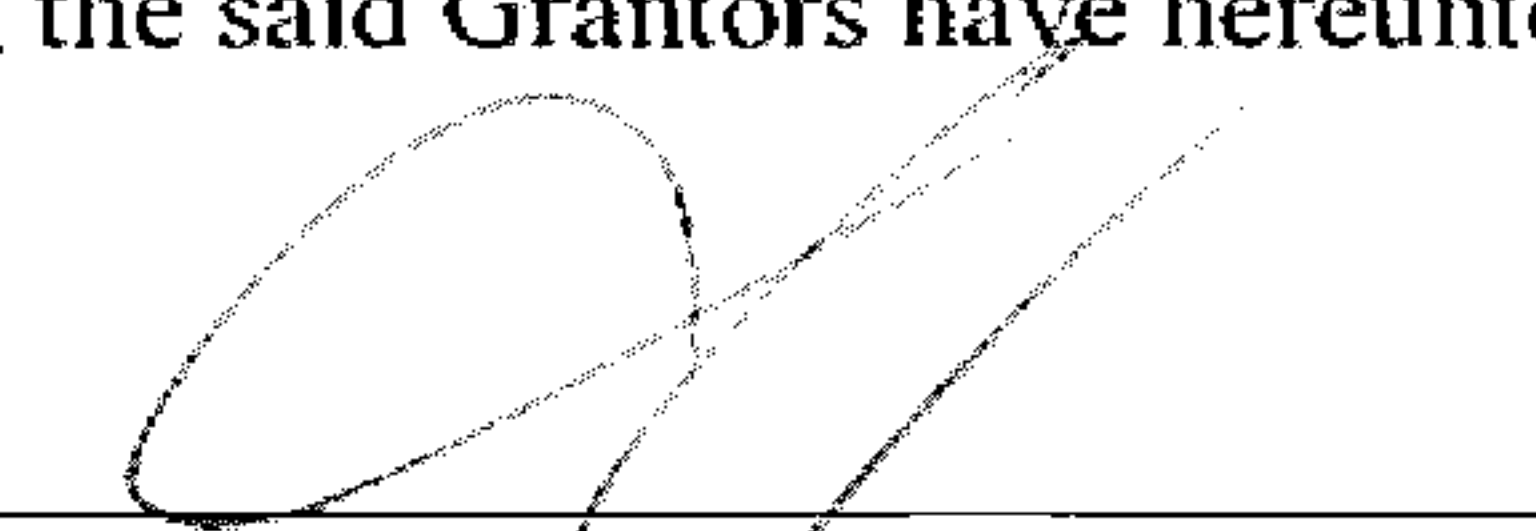
